TITLE: Motion to Approve Purchase of Swimming Pool Chemicals –\$182,510
(two-year total)

Recommendation

It is recommended that the City Commission approve the purchase of swimming pool chemicals via the Southeast Florida Governmental Purchasing Cooperative Group (Co-Op) two-year Contract No. 17-06-12-HR in the estimated amount of \$182,510; and authorize the City Manager or designee to approve renewal options coterminous with the Co-Op contract contingent upon approval and appropriation of funds.

Background

The City participated in the Co-Op bid for swimming pool chemicals. The City of Sunrise, acting as lead agency, awarded contracts at their February 28, 2017 Commission meeting. The City's combined spending estimates are as follows:

Pursuant to Section 2-198, Code of Ordinances of the City of Fort Lauderdale, Florida, "[t]he city manager or the city manager's designee shall have the authority to join with other units of government in cooperative purchasing plans when the best interest of the city would be served thereby."
