TITLE:	Motion to Approve Contract for Purchase of Demolition Services – AlliedBean Demolition, Inc. and The BG Group, LLC - \$537,850 (two-year total)

### **Recommendation**

It is recommended that the City Commission approve two-year contracts, in substantially the forms attached, with AlliedBean Demolition, Inc. as primary and The BG Group, LLC as secondary for the purchase of demolition services in the estimated amount of \$537,850; and authorize the City Manager or designee to approve two, one-year renewal options, contingent upon appropriation of funds.

### **Background**

The Unsafe Structures Board and the Special Magistrate have the authority to issue orders directing the City to secure or demolish structures. As these orders to demolish a property are determined on a case by case basis, estimates vary from year to year.

The Procurement Services Division issued Invitation to Bid No. 573-11878 and received five bids. The bids submitted by AlliedBean Demolition, Inc. and The BG Group, LLC have met all of the specifications of the bid and have been deemed the lowest cost, responsive and responsible bidders.

### Resource Impact

There will be a current fiscal impact to the City in the amount of \$268,925.
