TITLE: Resolution Approving the Conversion of SE 2nd Street between SE 8th

Avenue and SE 2nd Court (at 10th Terrace) to a One-Way Street

Recommendation

It is recommended that the City Commission adopt a resolution approving the conversion of SE 2nd Street between SE 8th Avenue and SE 2nd Court (at 10th Terrace) to a one-way street (Exhibit 1).

Background

The City received complaints from Beverly Heights regarding the mobility challenges along SE 2nd Street in this roadway segment. This roadway is heavily used by pedestrians walking their dogs within the travel lanes. This presents an unsafe condition. Given the limited right-of-way and the lack of sidewalk facilities, staff explored converting the roadway into a one-way condition.

Broward County Traffic Engineering Division (BCTED) conducted traffic studies along SE 2nd Street east of SE 8th Avenue in 2013 and more recently in 2016. The results of both studies showed that the eastbound direction has greater volumes than the westbound direction does. Therefore, it is recommended that the one-way direction should go eastbound. The westbound traffic will be diverted to SE 2nd Court. Staff feels this segment of SE 2nd Court can handle the increased volumes without causing significant impacts.

Resource Impact

There is no fiscal impact associated with this action. However, if the City moves forward with the one-way conversion, it will cost approximately \$20,000 to cover the cost of constructing an island with curb and landscape to restrict southbound movement and to install a pedestrian pathway. There is funding available in the current fiscal year within the operations budget.
