ADDENDUM TO ANY CONTRACT BETWEEN CITY OF FORT LAUDERDALE AND OFFICE DEPOT, INC., FOR THE PURCHASE OF OFFICE SUPPLIES

WHEREAS, the City of Fort Lauderdale, a Florida municipality, ("City"), is purchasing office supplies via the Southeast Florida Governmental Purchasing Cooperative (Co-op) contract No. 13-23R with Office Depot Inc., a Delware Corporation, duly registered as a Florida Foreign Corporation, ("Co-op Contract"),

NOW THEREFORE, as an addendum to any contract whereby the City purchases office supplies from Office Depot Inc., via the Co-op Contract, the City and Office Depot Inc., agree as follows:

Subject to Odebrecht Construction, Inc., v. Prasad, 876 F.Supp.2d 1305 (S.D. Fla. 2012), affirmed, Odebrecht Construction, Inc., v. Secretary, Florida Department of Transportation, 715 F.3d 1268 (11th Cir. 2013), with regard to the "Cuba Amendment," Office Depot Inc. certifies that it is not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or the Scrutinized Companies that Boycott Israel List created pursuant to Section 215.4725, Florida Statutes (2016), that it is not engaged in a boycott of Israel, and that it does not have business operations in Cuba or Syria, as provided in section 287.135, Florida Statutes (2016), as may be amended or revised.

The City may terminate this Agreement at the City's option if Office Depot Inc. is found to have submitted a false certification as provided under subsection (5) of section 287.135, Florida Statutes (2016), as may be amended or revised, or been placed on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List or the Scrutinized Companies that Boycott Israel List created pursuant to Section 215.4725, Florida Statutes (2016), or is engaged in a boycott of Israel or has been engaged in business operations in Cuba or Syria, as defined in Section 287.135, Florida Statutes (2016), as may be amended or revised.
