Hydrotreators 3 & 4 Influent Pipe Modifications Project - RF

Environmental Services, Inc. - \$93,388.46

Recommendation

It is recommended that the City Commission approve Change Order No. 2 with RF Environmental Services, Inc., in substantially the form attached, for the Fiveash Water Treatment Plant Hydrotreators 3 & 4 Influent Pipe Modifications Project in the amount of \$93,388.46.

Background

On October 18, 2016, the City Commission awarded a contract for the Fiveash Water Treatment Plant Hydrotreators 3 & 4 Influent Pipe Modifications Project to RF Environmental Services, Inc. for a total of \$444,096 (CAM #16-1217). This project is located at the Fiveash Water Treatment Plant, 4321 Northwest 9th Avenue, in the City of Fort Lauderdale and includes the construction, testing, piping replacement, and replacement of valves, fittings, and accessories within the influent vaults for Hydrotreators 3 and 4.

Change Order No. 1, dated March 3, 2017 in the amount of \$10,628.43, was issued to clean the existing 30 inch influent pipes and perform a pipe-line video inspection to determine if there were additional leaks farther down the pipe that were not evident from a visual inspection.

Change Order No. 2 is for the additional work required to repair leaks in the existing 30 inch influent piping at Hydrotreator 3, which were found during construction. Additionally, existing thrust blocks were unexpectedly encountered during excavation at Hydrotreator 4. In order to replace the influent pipe at Hydrotreator 4, these thrust blocks need to be removed and replaced. Leaks have also been discovered in the sludge recirculation piping at Hydrotreater 3, which will require pressure testing of the existing piping to locate the leaks and perform the repairs.
