Dear Ms. Grant:

Pursuant to the City's Unified Land Development Regulations (ULDR) Section 47-24.1.F.14 and 47-27.4, we are providing this letter to report the results of public participation meetings conducted for this Application.

- 1. <u>DRC notice.</u> Applicant provided 21-day notice of the DRC meetings by e-mail to the President of the following City-recognized association within 300-foot radius of the property:
 - Riverland Civic Association

Other than the association listed above, there are no other City-recognized associations within 300-feet of the property.

- 2. Meetings conducted. A public participation meeting was conducted at least 30 days prior to the scheduled Planning and Zoning Board meeting which is scheduled for March 15, 2017 at 6.30pm. The public meeting was held at a regularly scheduled meeting of the Riverland Civic Association on December 5, 2016 at 7:30 p.m. at the Riverland Park (Community Center) located at 950 SW 27th Ave, Fort Lauderdale, FL 33312.
- 3. Participants. An attendance sheet was completed at the meeting and is attached to this report.
- **4.** <u>Presentation materials.</u> The presentation materials presented at the public participation meeting consisted of a colored site plan and renderings of the buildings. Copies of the presentation materials are attached to this report.
- 5. Summary of comments from the associations. The comments received from the association included questions about the truck circulation and traffic. Applicant explained the property is currently approved for much greater intensity than the proposed development plan, and therefore, the projected traffic volumes are significantly less than the currently approved level of development. Some members of the association expressed concerns about FDOT's plans to implement an exit for the express lanes behind some of the single family homes in Riverland. FDOT's plans are not within Applicant's control; however we again, pointed out the

significant decrease in traffic expected from a self-storage, warehouse/distribution development versus the approved office/commercial development.

Addendum: PZB Public Participation Notification <<if applicable>>

Applicant must provide notification according to the procedure listed below for projects listed in Sec. 47-27.4.A.2.c.

- A minimum of 21 days prior to the Development Review Committee (DRC) meeting, a notice from the applicant via letter or e-mail shall be provided to any official city-recognized civic organization(s) within 300 feet of the proposed project, notifying of the date, time and place of the DRC meeting.
- Prior to submittal of application to the Planning and Zoning Board (PZB), a notice from the applicant via letter or e-mail shall be provided to official city-recognized civic organization(s) within 300 feet of the proposed project, notifying of the date, time and place of applicant's project presentation meeting to take place prior to the PZB hearing.
- The applicant shall conduct a public participation meeting(s) a minimum of 30 days prior to the PZB hearing.
- After the public participation meeting(s), the applicant shall provide a written report letter to the Department of Sustainable Development, with copy to subject association(s), documenting the date(s), time(s), location(s), number of participants, presentation material and general summary of the discussion after a public participation meeting(s) has taken place a minimum of 30 days prior to the PZB hearing. The report letter shall summarize the substance of comments expressed during the process and shall be made a part of the administrative case file record.
- The applicant shall, ten (10) days prior to DRC and again for the PZB, execute and submit to the department an affidavit of proof of public notice according to this section. If the applicant fails to submit the affidavit the public hearing will be postponed until the next hearing after the affidavit has been supplied.
