A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE FINAL OPERATING BUDGET, COMMUNITY INVESTMENT PLAN, AND PERSONNEL COMPLEMENT OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016, AND ENDING SEPTEMBER 30, 2017, BY APPROPRIATING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #17-0113, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 16-157, adopted on September 12, 2016, the City Commission of the City of Fort Lauderdale adopted the Final Operating Budget, Community Investment Plan, and Personnel Complement of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the Final Operating Budget of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017, is hereby amended by appropriating funds as set forth in Commission Agenda Memo #17-0113, a copy of which is attached hereto and incorporated herein.

SECTION 2. That this Resolution shall be in full force and effect upon final passage.

2017 – Appropriation

**Recommendation**

It is recommended that the City Commission adopt a resolution amending the Fiscal Year 2017 Budget, Personnel Complement, and Community Investment Plan (CIP).

**Background**

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff is recommending that the City Commission amend the FY 2017 Operating Budget, Personnel Complement, and Community Investment Plan by approving the following transfers and appropriations:

## **Fire-Rescue**

### **A. Reduction of Grant Funds - Grant Fund – Urban Area Security Initiative (UASI) Grant – (\$4,461.25)**

The United States Department of Homeland Security (USDHS) has provided financial assistance to the Miami urban area in the amount of \$5,158,500 through the FY 2016 Urban Area Security Initiative (UASI) Grant Program.

The City of Fort Lauderdale was expected to receive a sub-grant in the amount of \$208,615 with no required match. These funds were appropriated in the April Budget Amendment. However, the final award letter shows a sub-grant in the amount of \$204,154.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of (\$4,461.25) to reduce the previously anticipated amount of the UASI grant.

## **Police**

### **B. Appropriation of Grant Funds – Grant Fund – Florida Department of Transportation (FDOT) Pedestrian and Bicyclist Safety Program - \$3,419**

The focus of this project, which is a component of Florida's Bicycle/Pedestrian Focused Initiative Communication & High Visibility Enforcement Implementation Project, seeks to raise the awareness of pedestrians, bicyclists and motorists of safe behaviors. In November, (CAM No. 16-1213), the City accepted a grant award in the amount of \$27,324. The additional \$3,418.56 would enhance the outreach of the Police Department's Motor Unit by permitting them more hours to perform high visibility enforcement activities.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$3,419 for the FDOT grant.

## **City Manager's Office**

### **C. Appropriation of Unanticipated Revenues and Expenses – State Housing Initiatives Programs (SHIP) Fund – Accept Additional SHIP Funds - \$24,842**

In 2013, the Legislative Budget Commission approved a \$10 million allocation from the National Mortgage Settlement Funds to provide foreclosure counseling services to be administered by Florida Housing Finance Corporation (FHFC) through the Foreclosure Counseling Program (FCP). The 2016 housing bill allows FHFC to expand the types of counseling that can be provided to homeowners and prospective homebuyers to include other counseling and financial coaching.

Florida Housing Finance Corporation (FHFC) has made funding available from the FCP SHIP Funds to provide housing counseling. The City has received \$24,842 of which \$22,358 will be used for services and \$2,484 will be used for administration. These funds will be considered 2016-2017 SHIP funds and reported as housing counseling.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$24,842 for the SHIP grant.

### **Parks and Recreation**

#### **D. Transfer Between Capital Projects and Appropriation of Fund Balance – General Fund, Building Fund – Greg Brewton Sustainable Development Center Cooling System Replacement - \$261,000**

The Heating, Ventilation, and Air Conditioning units at the Greg Brewton Sustainable Development Center are beyond repair and require a complete replacement.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan (CIP) in the amount of \$261,000 for the Greg Brewton Sustainable Development Center cooling system replacement.

#### **E. Appropriation of Grant Funds – Grant Fund – National Recreation and Park Association (NRPA) Healthy Out-of-School Time Grant - \$25,000**

On March 8, 2017, the Parks and Recreation Department submitted a grant application to the National Recreation and Park Association (NRPA), in partnership with the Walmart Foundation, for the Healthy Out-of-School Time Program and was awarded funds in the amount of \$25,000. Grant funds will be used to enhance the Department's Healthy Eating and Physical Activity (HEPA) program offerings with supplies, curriculum and activities.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$25,000 for the NRPA Healthy Out-of-School Time grant. The grant acceptance is included as a companion CAM 17-0502.

### **Transportation and Mobility**

#### **F. Transfer Between Capital Project and Operating Budget – Parking Fund – Upgrade of Parking Management System - \$156,560**

The Transportation and Mobility Department requests a transfer from a capital project to the operating budget in order to upgrade its current parking management system.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan and Budget in the amount of \$156,560 for an upgrade of the parking management system.

## **Public Works**

### **G. Transfer Between Capital Projects – Water and Sewer General Capital Projects Fund – Fiveash Water Treatment Plant Hydrotreaters 3 & 4 - \$93,400**

The Fiveash Water Treatment Plant Hydrotreaters 3 & 4 Influent Pipe Modifications Project includes construction, testing, replacement of piping, valves, fittings and accessories within the influent vaults for Hydrotreaters 3 and 4. Proposed Change Order No. 2 is for additional work associated with repairing leaks in the existing piping for Hydrotreater #3 and repairing supports for existing piping on Hydrotreater #4.

The funds are available in the Water Treatment Plant Facilities - Concrete Restoration project as it will be reprioritized to a later date in order for this more urgent project to be completed.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$93,400 for Fiveash Water Treatment Plant Hydrotreaters 3 & 4. There is an associated CAM 17-0487.

### **H. Transfer Between Funds – General Fund, Vehicle Rental Fund – Wilton Manors Pumper Truck - \$208,264**

Fort Lauderdale Fire-Rescue has provided fire-rescue services under the terms of an interlocal agreement with the City of Wilton Manors since October 1, 2000. Under the terms of the agreement, Wilton Manors contributes to the vehicle replacement account for the replacement of a 2005 Pierce Pumper Truck. The amounts contributed, plus interest, were reserved in the Fleet Fund and General Fund. The 2005 Pierce Pumper Truck was replaced in December 2015. The General Fund reserve portion of \$208,264 must be transferred to the Fleet Fund for this purchase.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$208,264 for the Wilton Manors pumper truck.

### **I. Transfer Between Capital Projects – General Capital Projects Fund – West Lake Drive Bridge Restoration - \$350,000**

The City's contracted structural engineering consultant will develop a task order to design, permit and provide construction management services for the repairs of structural and aesthetic elements of the bridge. Construction funding has been requested in the FY2018 Community Investment Plan. This project is a priority because Florida Department of Transportation issued notice to the City indicating West Lake Drive Bridge is in need of repair.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$350,000 for West Lake bridge restoration.

**J. Transfer Between Capital Projects – General Capital Projects Fund – City Hall Americans with Disabilities Act (ADA) Improvements - \$246,000**

This project will account for costs associated with ADA improvements to City Hall 1st and 8th floors and access from the parking lot. Work includes, but is not limited to, 1st and 8th floors unisex toilet room improvement, drinking fountains, covered ADA access ramp from lobby to Commission Chambers, and modification to existing ADA access ramp into City Hall lobby.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$246,000 for City Hall ADA improvements.

**K. Appropriation of Fund Balance – Airport Fund – Taxiway Quebec and Alpha Resurfacing Project - \$266,297**

The Airport has initiated this project due to uneven pavement. The project consists of design and construction of sections of Taxiway Quebec and Taxiway Alpha. The scope of the project includes milling and saw cutting of the existing pavement, reworking/installing limerock base, installing new asphaltic concrete, and installing new pavement markings.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$266,297 for Taxiway Quebec and Alpha resurfacing project.

**Sustainable Development**

**L. Appropriation of Fund Balance – Building Permits Fund – Vehicle Purchase - \$194,677**

Due to an update in the Florida Building Code and an increase in the complexity of permit applications submitted, the Department of Sustainable Development (DSD) experienced an unprecedented surge in the time it takes to issue a permit. A mid-year budget modification in FY2016 brought additional staff members on board to help mitigate this issue. The department intended to utilize salary savings accumulated during the year to purchase one-time expense such as vehicles during the year. Vehicles for six (6) of these position were not purchased or encumbered during the year and funding for these vehicles needs to be appropriated from fund balance. The department is also including a request for one (1) vehicle for the Assistant Building Official, who currently does not have a permanently assigned vehicle. This vehicle will be primarily used to service the newly formed Permit by Affidavit program, conduct onsite inspections, and will make it possible to respond to jobsite emergencies.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$194,677 to purchase vehicles for inspectors.

**M. Appropriation of Fund Balance and Addition of 3 Full Time Positions to the City's Personnel Complement – Water Sewer Fund, Stormwater Fund, Building Fund, General Fund – Additional Engineering Positions - \$329,028 (the actual budget increase is \$164,514 but it's doubled due to internal chargebacks required to allocate expenses).**

Since FY 2013, the annual number of building permit applications has increased significantly. The aggregate value of construction applications has significantly increased from \$656,622,714 of value in FY 2013 to \$1,071,890,054 of value in FY 2016. There was a 2% decrease in the number of permits issued for FY 2016 from FY 2015; however, it should be noted that there was an influx in permit applications submitted in July 2015 due to a change in the Florida Building Code. We expect that between 25,000 and 26,000 permits annually will be closer to the normal rate of activity expected for the next three years. The increase in volume and complexity in permitting activity has required the City to hire additional plan review and inspection staff as well as rely on the use of overtime and contract services to meet the service demands. After re-evaluating operations, management has concluded that three (3) additional full-time positions are needed to handle this activity while also completing the permitting process more efficiently. The budget amendment includes funding for the remaining 13 pay periods of the fiscal year. The annual impact of hiring the three additional staff is estimated to be \$261,885. The recommended positions include:

- Two (2) Project Manager IIs
- One (1) Engineering Inspector I

Staff recommends that the City Commission amend the FY 2017 Budget and Personnel Complement in the amount of \$329,028 and 3 full time equivalent positions.

Where applicable, the approval of companion agenda items listed below is contingent upon the approval of the respective companion items as part of this consolidated budget amendment.
