**TITLE**: Motion to Approve Assumption of Contract and Consent to Assignment of

Enterprise Resource Planning System Implementer Agreement and to Approve Third Party Vendor Agreements with Emphasys Computer Solutions, Inc., MHC Software, Inc., and Finite Matters Ltd., Inc.

### Recommendation

It is recommended that the City Commission approve and authorize execution of an Assumption of Contract and Consent to Assignment of Enterprise Resource Planning (ERP) system implementer agreement from Ciber, Inc., (Ciber), to Infor (US), Inc., (Infor), in substantially the form attached, and approve third party ERP agreements with Emphasys Computer Solutions, Inc., (Emphasys), MHC Software, Inc., (MHC), and Finite Matters Ltd., Inc., (FML), in substantially the forms attached.

### **Background**

On March 20, 2017, Ciber entered into an asset purchase agreement with Infor whereby Ciber transferred to Infor the majority of its business and assets relating to the services it provides in connection with Infor's software products. The closing of the transaction took place on March 31, 2017.

On September 7, 2016 (CAM 16-0900) the City Commission approved vendors and funding for the additional third-party software components required for the ERP system solution. Those license and support agreements are with Emphasys, FML, and MHC.

The City will have to purchase an additional FML license for the Budget Office, now part of the City Manager's Office. Furthermore, FML was unable to honor the original \$7,500 cost of maintenance submitted in 2014 and had to increase the amount to \$9,995. However, as negotiated, FML agreed to waive the first year's maintenance cost which permitted the City to purchase an additional license without accruing extra cost. In addition, the City is able to procure the required commercial off- the- shelf Adobe products, including the additional requirement for the extra FML Licenses from SHI International Corp. via General Services Administration (GSA) contract #GS-35F-0111K in the amount of \$17,811 providing for additional savings over previously budgeted FML

priced licenses. As a result, the previous Commission-approved first year total of \$94,838 will only increase by \$315.90 for a new total of \$95,153.90.

## **Resource Impact**

There will not be a fiscal impact to the City.
