TITLE: Motion to Approve Annual Contract for Chain Link and Picket Fences –

Tropic Fence, Inc. - \$510,946

Recommendation

It is recommended that the City Commission award an annual contract, in substantially the form attached, to Tropic Fence, Inc. (Tropic) for the chain link and picket fences in the estimated amount of \$510,946; and authorize the City Manager to approve three one-year renewal options contingent upon availability and appropriation of funds.

Background

The Parks and Recreation Department maintains various types of fences for numerous City parks and facilities. Repairs and installation of new fencing materials are constantly needed. Specific line items, based upon line item pricing, will be used as they relate to the required repairs throughout the contract term. Several other departments also have installation and repair needs and their estimated quantities are included in the bid tabulation.

On April 12, 2017, the Procurement Services Division issued Invitation to Bid Number 272-11916. Two complete bids and one partial bid were received on May 3, 2017. The bid response submitted by Tropic was reviewed for compliance with the specifications of the bid and has been deemed the lowest cost, responsive, and responsible bidder recommended for award.

Resource Impact

There will be a fiscal impact to the City in the estimated amount of \$135,400 for FY 2017 operating budget in the accounts listed below. Future expenditures are contingent upon approval and appropriation of the annual budget.
