TITLE: Resolution Authorizing the Acceptance of a Grant from Broward County

for Fiscal Year (FY) 2017 Emergency Medical Services (EMS) County

Grant Program

Recommendation

It is recommended that the City Commission approve a resolution authorizing the City Manager to accept a grant from Broward County Office of Medical Examiner and Trauma Services – Emergency Medical Services (EMS) County Grant Program; and to execute any documents required to accept funds from Broward County.

Background

The State of Florida, Department of Health, Bureau of Emergency Medical Services through Broward County Office of Medical Examiner & Trauma Services has subgranted the FY 2017 Broward County Emergency Medical Services (EMS) Grant Program to the City of Fort Lauderdale to provide funds to address EMS equipment, training and other needs.

Fort Lauderdale Fire Rescue (FLFR) consists of 401 personnel with approximately 380 of those trained to the level of firefighter/paramedic. With a call volume of almost 55,000 runs annually the department runs a diverse number of medical calls. Approximately 25-30% of our medical call volumes are pediatrics. Fire Rescue paramedics are the "first line of defense" for emergency medicine in many of our neighborhoods, and for many of these neighbors, we are the sole medical treatment provider.

FLFR's training bureau is responsible for all of the EMTs and paramedics continuing education credits (CEUs). On an annual basis, we provide 24-48 pediatric advanced life support (PALS) classes a year to ensure that our medics/EMTs are certified and up-to-date in pediatric life support. In addition to this training, the Training Bureau does year-round advanced pediatric and adult airway training which includes both BLS and ALS airway management. Furthermore, FLFR has 2-3 new hire classes a year containing 12-20 new paramedics. We train all of our new hires on pediatrics in our rookie program as well as monthly pediatric testing over the period of six (6) months until they are "signed-off" paramedics in our system.

In order to keep our crews well trained, we need to keep our equipment in working order, clean and ready to use at all times as our medical training is continuous throughout the year. FLFR has requested grant funds to purchase a 5-year old resuscitation and emergency simulator along with a newborn resuscitation and emergency simulator. Both resuscitation and emergency simulators will have a touch screen tablet, wireless control, and modified defibrillation patch accessories for the 5-year old and a one day training service and installation for the simulators.

Resource Impact

There is a positive fiscal impact to the City in the amount of \$14,282.00. Funds are being appropriated through companion agenda item, CAM #17- 0114
