TITLE: Motion to Approve Contract for Lake Estates Small Water Main
Improvements – V Engineering & Consulting Corp. - \$1,716,000

Recommendation

It is recommended that the City Commission award a contract, in substantially the form attached, to V Engineering & Consulting Corp. for the Lake Estates Small Water Main Improvements Project in the amount of \$1,716,000.

Background

The utility service area within the Lake Estates Neighborhood requires water main improvements to remedy water quality and reliability deficiencies. Occurrences of brown tap water, dead end pipe runs, and the age and size of the existing piping must be addressed. New fire hydrants; larger, new water mains and valves; dead end loops and metal pipe beyond its design life will all be repaired or replaced. In addition, the existing ductile iron water lines will be replaced with new polyvinyl chloride water mains to help prevent future corrosion.

On March 22, 2017, the Procurement Services Division issued Invitation to Bid Number 473-11860 and on April 17, 2017, five bids were received. All bids were reviewed for compliance with the solicitation specifications. The proposal submitted by V Engineering & Consulting Corp. has been deemed the lowest cost, responsive, and responsible bidder recommended for award.

Resource Impact

There will be a fiscal impact to the City in the amount of \$1,716,000 for construction and \$350,000 for estimated in-house project management fees, or a total of \$2,066,000. The available balance in the chart below reflects the amount remaining after the removal of pre-encumbrance established for this purchase. Pre-encumbrance is included on requisition RQ1707976 in the amount of \$1,700,000.
