A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, REGARDING THE APPEAL OF THE PLANNING AND ZONING BOARD'S ACTION DENYING THE REZONING OF **CERTAIN** PROPERTY LOCATED ON THE SOUTH SIDE OF SUNRISE BOULEVARD, EAST OF NORTHWEST 2ND AVENUE, NORTH OF NORTHWEST 9TH STREET AND WEST OF ANDREWS BOULEVARD AVENUE FROM BUSINESS (B-1) RESIDENTIAL MULTIFAMILY MID RISE/MEDIUM HIGH DENSITY (RMM-25) TO NORTHWEST REGIONAL ACTIVITY CENTER - MIXED USE NORTHEAST (NWRAC-MUne). MAKING CERTAIN FINDINGS AND SETTING A PUBLIC HEARING TO CONSIDER THE APPEAL BEFORE THE CITY COMMISSION AT 6:00 P.M. ON , 2017.

WHEREAS, in accordance with Section 47.26B, the City Commission has reviewed the record at its June 20, 2017 regular meeting and determined that either there was a departure from the essential requirements of law in the proceedings or that competent substantial evidence does not exist to support the decision of the Planning and Zoning Board; and

WHEREAS, the City Commission will conduct a de novo hearing on the rezoning application;
