A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE OFFICIAL MAP OF THE CITY OF FORT LAUDERDALE, FLORIDA, TO INCLUDE THE NAME "SEVEN ISLES DRIVE" AS THE PRIMARY STREET NAME TO THAT SECTION OF NE/SE 23RD AVENUE BETWEEN LAS OLAS BOULEVARD AND DESOTA DRIVE.

WHEREAS, the existing street signage on that section of NE/SE 23rd Avenue between Las Olas Boulevard and Desota Drive currently displays the primary street name of the "Seven Isles Drive"; and

WHEREAS, Section 25-1 of the Code of Ordinances of the City of Fort Lauderdale, Florida provides that the names of all streets within the City of Fort Lauderdale shall be as specified on the Official Map of the City of Fort Lauderdale prepared by the City Engineering Department; and

WHEREAS, the Transportation and Mobility Department of the City of Fort Lauderdale has determined that the existing "Seven Isles Drive" street name is not an official street name in the City of Fort Lauderdale nor is it reflected on the Official City Map; and

WHEREAS, the Transportation and Mobility Department of the City of Fort Lauderdale requests to officially recognize the "Seven Isles Drive" street name as the primary street name for that section of NE/SE 23rd Avenue between Las Olas Boulevard and Desota Drive on the Official City Map; and

WHEREAS, the Seven Isles Home Owners Association, which represents the homeowners on that section of NE/SE 23rd Avenue between Las Olas Boulevard and Desota Drive, during its monthly meeting on October 13, 2016, passed a resolution in favor of the formal adoption of the "Seven Isles Drive" street name;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The City Commission of the City of Fort Lauderdale desires to formally amend the Official Map of the City of Fort Lauderdale to include "Seven Isles Drive" as the primary street name of that section of NE/SE 23rd avenue between Las Olas Boulevard and Desota Drive.
