- 2. Provide 45 minute fire rating for doors 118, 217, 221, 222, & 223, required by code and inadvertently omitted from the design drawings.
- 3. Remove 60 square feet of concrete sidewalk at front of building, and re-pour for installation of new flagpole.
- 4. Additional cost for permit fees in excess of the contract allowance amount of \$30,000

Due to the additional scope associated with this change order an additional thirteen (13) calendars days will be added to the contract time.

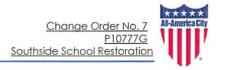

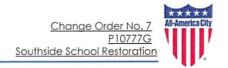

# **Conditional Letter of Delivery**

Dear Scott;

We are in receipt of your Change Order No. 07 dated 07/11/17, issued pursuant to our RCO # 50 dated 4-27-17, RCO # 51 dated 3-30-17, RCO # 52RR dated 6-2-17 and RCO 53 dated 5-15-17.

We are herewith returning (4) fully executed copies to your office. Accordingly, our execution and signature of this Change Order Item at this time will not constitute a relinquishment on the part of Di Pompeo Construction Corp. of its rights to pursue additional time and/or monetary compensation should additional costs and or time associated with these changes in the scope of work, not discernable at this time, become evident and justifiable. Our rights to reserve additional time and or monetary compensation are based upon the work contained within the aforementioned change orders and when we receive an executed change order approved by the Commission of the City of Ft. Lauderdale. The times denoted on each change order may change as the time when we receive the executed and approved change orders and based upon how the critical path will be affected for each scope contained within the change orders that will allow the work to progress and complete. Our updated schedule will denote if any additional days will be required and we reserve the right to request added time and money if the days shown on this change order are exceeded since the days granted were speculative and not incorporated into a critical path schedule to show the true impact. Further, we submitted our daily general conditions rate of \$ 1,153.00 per day and the City requested us to lower our daily rate to \$ 800.00 and told us to add 10% office overhead. However, if the 10% office overhead is not accepted at a later date by the City, our daily rate of \$ 800.00 will need to be reverted back to \$ 1,153.00 per day.

Lastly on 6/19/17 we sent you an email advising you that we are requesting a (10) day time extension for delays due to FPL not turning on power at Southside School Restoration and weather delays. We had several unusual days of rain hindering us from performing site work as well as HVAC and Electrical. We are requesting that the time extension be granted and approved on the next change order.
