- **TITLE:** Motion to Approve Contracts for Stormwater Lining, Closed Circuit Television Inspection, and Trenchless Technologies Construction GPE Engineering & General Contractor Corp. and Lanzo Trenchless Technologies, Inc.-South \$1,000,000

Recommendation

It is recommended that the City Commission approve two-year contracts, in substantially the forms attached, with GPE Engineering & General Contractor Corp. (GPE) and Lanzo Trenchless Technologies, Inc. - South (Lanzo) for the stormwater lining, closed-circuit television (CCTV) inspection, and trenchless technologies project in the estimated aggregate amount of \$1,000,000 subject to further appropriations based on City needs; and authorize the City Manager to approve two, one-year renewal options, contingent upon the annual appropriation of funds.

Background

This project is an annual contract for construction repair services, including the restoration, testing, CCTV inspection, pipe cleaning, and rehabilitation of stormwater pipelines, structures, tidal valves, exfiltration trenches, drainage wells, and other drainage components and appurtenances. The selected contractors will provide construction services on an as-needed basis for public stormwater infrastructure based on pre-determined line item prices indicated in each contract.

The Procurement Services Division issued Invitation to Bid No. 673-11892 on June 6, 2017 and received two bids. The bids submitted by GPE and Lanzo have met all of the specifications of the bid, and have been deemed responsive and responsible bidders.

Resource Impact

There will be a current fiscal year impact to the City in the amount of \$500,000. Funds for this purchase in the amount of \$500,000 are available in the FY 2017 Budget in the account listed below. Future expenditures are contingent upon adoption of future year budgets.
