**TITLE:** Motion to Approve Contract for Purchase of Fort Lauderdale Executive  
Airport Taxiway Foxtrot Pavement Rehabilitation Project – General  
Asphalt Co., Inc. - \$2,158,102

---

**Recommendation**

It is recommended that the City Commission approve a contract, in substantially the form attached, with General Asphalt Co., Inc. for the Fort Lauderdale Executive Airport (FXE) Taxiway Foxtrot Pavement Rehabilitation Project in the amount of \$2,158,102.

**Background**

The Florida Department of Transportation (FDOT) performed a review of FXE's pavements and issued a report with its findings in June of 2015. The review determined that Taxiway Foxtrot's Pavement Condition Index (PCI) has a value of 59. The FDOT recommends a minimum service level PCI of 65 for parallel taxiways. In addition, the geometry of taxiway intersections along Taxiway Foxtrot are non-compliant with the current Federal Aviation Administration (FAA) design standards.

To address the noted areas of concerns, work on this contract includes but is not limited to pavement milling and demolition, asphalt paving, limerock, electrical conduits, cabling, installation of new taxiway edge-lights and airfield guidance signs, and pavement striping.

On May 15, 2017, the Procurement Services Division issued Invitation to Bid No. 673-11965. Four bids were received on June 15, 2017. The bids submitted were reviewed for compliance with the specifications. General Asphalt Co., Inc. has been deemed the lowest cost, responsive and responsible bidder.

The FAA has provided a grant for reimbursement of eligible construction costs for this project. The remaining grant match of \$233,810 is available from the project budget.

### **Resource Impact**

There will be a fiscal impact to the City in the amount of \$2,158,102 for the contract award. Funds for this award, in the amount of \$233,810, are available in the FY 2017 Community Investment Plan in the accounts listed below.
