## **RESOLUTION NO. 17-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A DEVELOPMENT PERMIT INCLUDING THE ALLOCATION OF 329 DOWNTOWN DWELLING UNITS WITHIN THE FORT LAUDERDALE DOWNTOWN REGIONAL ACTIVITY CENTER LAND USE DESIGNATION FOR A MIXED-USE RESIDENTIAL DEVELOPMENT KNOWN AS "LAS OLAS WALK-NORTH" LOCATED AT 116 SOUTH FEDERAL HIGHWAY, FORT LAUDERDALE, FLORIDA, IN A RAC-EMU ZONING DISTRICT.

WHEREAS, an application for a Site Plan Level II development permit including the allocation of 329 downtown dwelling units has been submitted to develop a mixed-use residential development of an 8-story development consisting of 329 downtown dwelling units and a parking garage for the project known as "Las Olas Walk-North", located at 116 South Federal Highway, Fort Lauderdale, Florida, in the Downtown RAC-EMU zoning district within the Fort Lauderdale Downtown Regional Activity Center Land Use Designation; and

WHEREAS, the Development Review Committee (Case No. R16059) approved the Site Plan Level II development permit including the allocation of 329 downtown dwelling units on October 25, 2016, subject to conditions; and

WHEREAS, pursuant to Section 47-13.20.B.4 of the City of Fort Lauderdale, Florida Unified Land Development Regulations ("ULDR"), the approval of the development permit including the allocation of downtown dwelling units shall not take effect until the application is reviewed and approved by the City Commission; and

WHEREAS, the City Commission at its meeting of September 19, 2017, reviewed the application for a Site Plan Level II development permit including the allocation of 329 downtown dwelling units submitted by the applicant, as required by the ULDR, and finds that such application conforms with the provisions of the ULDR as provided herein;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the application for a Site Plan Level II development permit including the allocation of 329 downtown dwelling units submitted to develop an 8-story residential building

consisting of 329 downtown dwelling units and a parking garage for the project known as "Las Olas Walk-North", located at 116 South Federal Highway, Fort Lauderdale, Florida in the Downtown RAC-EMU zoning district within the Fort Lauderdale Downtown Regional Activity Center Land Use Designation is hereby approved, subject to the conditions imposed by the Development Review Committee and City Commission.

<u>SECTION 2</u>. That pursuant to the provisions of the ULDR, the proper City officials are hereby authorized to issue the necessary building and use permits subject to the conditions imposed by the Development Review Committee and City Commission.

<u>SECTION 3</u>. The conditions contained herein are intended to memorialize the conditions expressed in the record of the hearings at which the application for the development permit was reviewed. In the event that the record of the proceedings contradicts or contains additional conditions not reflected in this instrument, the conditions expressed on the record of the proceedings shall prevail and are incorporated herein.

<u>SECTION 4</u>. Issuance of a development permit by a municipality does not in any way create any right on the part of an applicant to obtain a permit from a state or federal agency and does not create any liability on the part of the municipality for issuance of the permit if the applicant fails to obtain requisite approvals or fulfill the obligations imposed by a state or federal agency or undertakes actions that result in a violation of state or federal law.

<u>SECTION 5</u>. This approval is conditioned upon the applicant obtaining all other applicable state or federal permits before commencement of the development.
