### **RESOLUTION NO. 17-158**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING THE FINAL OPERATING BUDGET AND COMMUNITY INVESTMENT PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016, AND ENDING SEPTEMBER 30, 2017, BY APPROPRIATING FUNDS AS SET FORTH IN CITY COMMISSION AGENDA MEMO #17-0841, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 16-157, adopted on September 12, 2016, the City Commission of the City of Fort Lauderdale, Florida, adopted the Final Operating Budget and Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the Final Operating Budget and Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017, are hereby amended by appropriating funds as set forth in Commission Agenda Memo #17-0841, a copy of which is attached hereto and incorporated herein.

<u>SECTION 2</u>. That the Riverland Annexation Road Restoration Project, the 911 Call Center and Dispatch Transition Project, and the Snyder Park Boardwalk Replacement Project appropriated in the Community Investment Plan of the City of Fort Lauderdale, Florida, for the Fiscal Year beginning October 1, 2016, and ending September 30, 2017, are hereby abandoned.

<u>SECTION 3</u>. That this Resolution shall be in full force and effect upon final passage.

Resolution Approving the Consolidated Budget Amendment to Fiscal Year

2017 – Appropriation

#### Recommendation

It is recommended that the City Commission adopt a resolution amending the Fiscal Year 2017 Budget and Community Investment Plan (CIP) and abandoning the Riverland Annexation Road Restoration, 911 Call Center and Dispatch Transition, and Snyder Park Boardwalk Replacement projects.

#### **Background**

Examples of recommended actions within the budget amendment are:

- transfer between funds;
- transfer between capital and operating budgets;
- transfer between capital projects;
- acceptance and appropriation of grant funding;
- amendment to staffing level;
- appropriation from fund balance; and
- appropriation for modified revenue and related expenditures.

Staff is recommending that the City Commission amend the FY 2017 Operating Budget and Community Investment Plan by approving the following transfers and appropriations:

### **Transportation and Mobility**

A. Transfer Between Capital Projects and Operating Funds - Parking Fund, Arts and Science District Garage Fund - Downtown Wayfinding and Information Signage - \$513,511.48

The purpose of this request is to consolidate the funding needed for the design and signage enhancements for the City's three municipal parking garages and thirty surface lots in the amount of \$513,511.48.

Staff recommends that the City Commission amend the FY 2017 Budget and Community Investment Plan in the amount of \$513,511.48 for Downtown Wayfinding and Information Signage. There is an associated CAM 17-0616.

B. Transfer of Operating Funds to Trust Funds - General Fund - Traffic Study Subsidiary Accounts - \$30,396.59

Traffic studies required by the City during the Development Review Committee (DRC) process are often paid by the person or company requesting the project permits. Historically, these funds were accounted for as General Fund revenues where the traffic studies were also funded. Any unspent funds would be refunded to the person or company once the study is completed based upon actual costs incurred by the City.

Since these are not City funds, they are now more appropriately accounted for in subsidiary accounts under the person or company name until the study is completed and reconciliation occurs.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$30,396.59 to establish traffic study subsidiary accounts outstanding from prior years.

C. Transfer of Funds - Grant Fund, General Fund - FTA New Freedom Mobility Management Grant Match - \$11,141.60

The Mobility Management consultant has completed the Transit Master Plan under budget which has resulted in a savings of \$11,414.60 in the grant's match account funded from the General Fund.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$11,141.60 to transfer the FTA New Freedom Mobility Management grant match to be used for community bus services.

D. Appropriation of Fund Balance - Airport Fund - Downtown Helistop Elevator Repair and Modernization - \$88,788

The Airport has initiated this project to address the operational issues as well as to modernize the elevator systems due to operational issues. The project consists of upgrading the existing power unit and controller, upgrading the lighting system, replacing the hinged door framing in the flight deck, replacing the fan and thermostat in 8/22/2017

the electrical room, installation of fire alarm initiating devices, installation of flush mounted warning lights on the flight deck to notify when the elevator doors are opening, as well as several other upgrades to the system.

The project is scheduled to be awarded to Eastern Elevator Service, Inc. in the amount of \$170,812. Funding in the amount of \$99,124 is available in the project fund; however funds are needed to cover \$71,250 in additional construction costs and \$17,538 in internal project management charges. The required funding is available in the Airport's fund balance.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$88,788 for the downtown helistop elevator repair and modernization project. There is an associated CAM 17-0833.

# E. Appropriation of Grant Funds – Airport Fund – Taxiway Foxtrot Pavement Rehabilitation Construction - \$2,250,905

As part of the ongoing Statewide Airfield Pavement Management Program, the Florida Department of Transportation (FDOT) performed a review of Fort Lauderdale Executive Airport's (FXE) runway and taxiway pavements, and issued a report with its findings in June of 2015. The review determined that a portion of Taxiway Foxtrot, which is west of Taxiway Golf, has a Pavement Condition Index (PCI) value of 59. FDOT recommends a minimum service level PCI of 65 for parallel taxiways.

The construction cost for this project is estimated to be \$2,138,102 and the inspection and administrative services cost is estimated at \$362,904. The FAA is anticipated to provide grant funding for 90% of eligible project costs for construction. Staff prepared a grant application to submit to the FAA for acceptance of a grant in the amount of \$2,250,905.

In an effort to expedite the execution of the grant agreement, staff is requesting to appropriate the \$2,250,905 anticipated grant funds in anticipation of the agreement. The match requirement in the amount of \$125,050 is available in the project budget. If the grant is not awarded, the related expenditures will be paid by the Airport Fund.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$2,250,905 for the Taxiway Foxtrot Pavement Rehabilitation project. There is an associated CAM 17-0933.

### <u>Police</u>

# F. Appropriation of Grant Funds - Grant Fund - Florida Department Juvenile Justice Grant - \$27,777

In January 2015, the City submitted an application to the Florida Department of Juvenile Justice (FDJJ) in response to a solicitation for proposals from law enforcement agencies to deliver services that address the issue of overrepresentation of minority youth in 8/22/2017

Florida's juvenile justice system. In September 2015, the City was awarded \$27,777 in grant funding in order to address Disproportionate Minority Contact (DMC) thru the provision of DMC curriculum training, youth focus groups and DMC analysis reports for the period of September 1, 2015 to August 31, 2016. Pleased with the success of this program as administered by the Fort Lauderdale Police Department, FDJJ extended the grant by twelve months in 2016. As that program period comes to an end, FDJJ has again proposed to extend the grant period by another year. They have also increased the grant award to \$83,331 in order to accommodate the provision of the additional DMC trainings, focus groups, and analysis reports. The revised grant period is September 1, 2015 through August 31, 2018. No matching funds are required.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$27,777 for the Florida Department of Juvenile Justice Grant. There is an associated CAM 17-0846.

#### **Parks and Recreation**

## G. Appropriation of Grant Funds - Grant Fund - Summer Food Program - \$150,306

The City of Fort Lauderdale anticipates a grant in the amount of \$150,306 from the United States Department of Agricultural (USDA) to provide free nutritional lunches and snacks at the various City parks from June 19, 2017 – August 11, 2017. The grant funds will reimburse the City for lunches and snacks, operational expenses, and program monitoring.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$150,306 for the summer food program grant.

## H. Appropriation of Grant Funds - Grant Fund - Make a Splash Grant - \$1,500

The USA Swimming Foundation's Make a Splash initiative is a national child-focused water safety campaign, which aims to provide the opportunity for every child in America to learn to swim. Through Make a Splash, the USA Swimming Foundation partners with learn-to-swim providers and water safety advocates across the country to provide swimming lessons and educate children and their families on the importance of learning how to swim.

During a Make a Splash Tour Event, the City of Fort Lauderdale learned that it was awarded \$1,500 to promote water safety via the Parks and Recreation Department's Learn-to-Swim Program. With the assistance of the USA Swimming Foundation grant provided through the Make a Splash Tour, the City of Fort Lauderdale will be reimbursed for providing children with free or reduced-cost swim lessons.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$1,500 for the make a splash grant acceptance. There is an associated CAM 17-0958.

I. Transfer Between Capital Projects and Un-appropriation of Grant Funds –
 Grants Fund, General Capital Projects Fund – Snyder Park Dog Ramp Projects – \$120,004

Abandoning of Snyder Park Boardwalk Replacement Project

On September 1, 2015, the City Commission approved the appropriation of grant and cash match funds in the amount of \$50,000 for the Snyder Park boardwalk replacement project through the Florida Recreation Development Assistance Program. On March 7, 2017, \$130,000 was also appropriated from another project to assist with the replacement of the boardwalk. Due to the timing and funding required to complete this project, staff recommends that the City withdraw from the grant and abandon the project. Staff recommends the remaining \$170,004 from the Snyder Park Boardwalk Project be appropriated to the Snyder Park Dog Ramp Project.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$120,004 to complete the Snyder Park Dog Ramp Project and abandon the Snyder Park Boardwalk project.

### **Information Technology Services**

J. Appropriation of Capital Lease Proceeds – Central Service Fund – Public Safety Radio Technology Upgrade – \$6,383,588

The City's current fleet of subscriber radios is Motorola XTS series. The XTS series are only P25 Phase I, and Broward County has indicated their plans to upgrade its system to P25 Phase II. Therefore, the City's public safety fleet of radios will not function on the County system, which will impact interoperability. The replacement APX subscriber radios will meet P25 Phase II standards and Broward County compliance as well as provide additional capabilities for public safety users.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$6,383,588 for the public safety radio technology upgrade.

### **Public Works**

K. Transfer Between Capital Projects – Stormwater Fund – 777 Bayshore Drive Stormwater Project – \$150,000

This project will construct new concrete valley gutter, concrete sidewalk, swales, install new tidal valves, and other stormwater improvements necessary to attenuate chronic flooding issues due to rainfall and high tides at Bayshore Drive. This project will incur additional costs to the original construction estimate due to updated stormwater construction contract costs. Funding in the amount of \$150,000 is available for use in

8/22/2017 CAM #17-0841 another stormwater capital project, 3301 NE 16th Street Stormwater Improvements that was completed under budget.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$150,000 for the 777 Bayshore Drive stormwater project.

## L. Transfer Between Operating Budget and Capital Project – Central Regional Fund – Sludge Weighing Truck Scales - \$17,700

This project will replace two existing truck scales located in the biosolids dewatering building at George T. Lohmeyer Wastewater Treatment Plant. The primary function of the scales is to weigh the trailers that transport sludge for disposal to ensure the trailers are not overloaded, and to ensure accurate accounting of quantities of sludge being removed and disposed. Additional funds are required for this project because of the electrical work associated with the installation of the two truck scales. The funds are available in George T. Lohmeyer operating budget.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan and Budget in the amount of \$17,700 for the installation of sludge weighing truck scales.

# M. Appropriation of Fund Balance – Water & Sewer General Capital Projects Fund – Emergency Repair 30 inch Force Main A-Repump to George T. Lohmeyer and Overtime Expense - \$2,910,456

On June 1, 2017, the City Manager declared an emergency pursuant to § 287.055(9)(c)6, Florida Statutes as to the 30" Force Main from A-Repump Station to GTL. This pipe experienced 7 breaks requiring emergency repairs in the last 18 months within the Tarpon Bend and Sailboat Bend neighborhoods. The resulting cost to repair the force main and resolve claims against the City exceeded \$1 million.

Funding for this project was initially appropriated in the July Budget Amendment in the amount of \$13,500,000 based upon staff estimates. Based on the final cost summary, an additional \$1,410,456 is needed to complete the project. In addition, \$1,000,000 is necessary for the overtime incurred and \$500,000 for additional contractual expense to operate the vacuum trucks while the force main is being repaired.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan and Budget in the amount of \$2,910,456 and abandon the Fiveash Water Treatment Plant Disinfection Improvements project to facilitate the emergency repair of a 30 inch force main A-repump to George T. Lohmeyer and overtime expense associated with vacuum truck operation.

N. Transfer Between Capital Projects – General Capital Projects Fund – Butler Building Replacement - \$1,030,000

Abandonment of the 911 Call Center and Dispatch Transition Project

The Butler building at George T. Lohmeyer Wastewater Treatment Plant is in need of replacement. Funds are available in the 911 Call Center and Dispatch Transition project and in the Facilities Assessment - Interior Repair /Construction project for this expense.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$1,030,000 for replacement of the Butler Building.

## O. Transfer Between Capital Projects – Water & Sewer General Capital Projects Fund – Pump Station B-10 Rehabilitation – \$344,772.56

Pump station B-10 serves a large sewer basin. This project is a priority because of the depleted physical condition of the station. The proposed work will rehabilitate the station, with the removal and replacement of all existing equipment, including electrical, mechanical, and ventilation. Replacement of existing ladders, grates, and hatches are also part of the project.

Additional funding in the amount of \$344,772.56 (including construction management fees) is required to award this project to the low bid contractor. Funds are available to be used from Imperial Point Large Watermain – Phase 2, Northeast 57th Street Small Watermain Improvements, Sewer Basin D-40 Rehabilitation, and Pump Station Rehabilitations A12, B10, B22, D37 & D45 projects which were all completed under budget.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$344,772.56 for pump station B-10 rehabilitation.

# P. Transfer Between Capital Projects – Water & Sewer General Capital Projects Fund – Abandon Wellfields at Fort Lauderdale Executive Airport - \$121,000

This project is for the abandoning of six water supply wells at the Fort Lauderdale Executive (FXE) Airport and is a high priority. The City of Fort Lauderdale will properly abandon six (6) wells at the Fort Lauderdale property and its vicinity. Abandoning a well must be done as a construction project with a construction permit in accordance with the entire regulatory requirement. Funding for this project is available in the SW 8<sup>th</sup> Street (SW 3<sup>rd</sup> Avenue and 4<sup>th</sup> Avenue) Sanitary Sewer Project, which was completed under budget.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$121,000 to abandon wellfields at the Fort Lauderdale Executive Airport.

## **Community Redevelopment Agency (CRA)**

# Q. Transfer Between Funds – CRA Fund, CRA Business Incentives Fund – Land Acquisition – \$60,000

In order for Community Redevelopment Agency (CRA) to purchase property from the City, the funding needs to be moved to the proper CRA Incentive Account.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$60,000 to transfer funds appropriated for business incentives for land acquisition. There is an associated CAM 17-0944.

### **City Manager**

R. Appropriation of Unanticipated Revenue – General Capital Projects Fund – Lauderdale Beach Homeowners Association Traffic Calming Contribution – \$10,000

The City Commission awarded a Neighborhood Community Investment Program (NCIP) matching grant in the amount of \$35,000 to the Lauderdale Beach Homeowners Association for traffic calming on NE 27 Street. This grant requires a match from the Homeowners Association and additional funding to complete the project. The Homeowners Association provided \$44,000 to the City, which was accepted and appropriated as part of the August 2016 Budget Amendment. Additional funds in the amount of \$10,000 are now being provided from the Homeowners Association to award the contract.

Staff recommends that the City Commission amend the FY 2017 Budget in the amount of \$10,000 to accept and appropriate a contribution from the Lauderdale Beach Homeowners Association.

S. Transfer Between Capital Projects – General Capital Projects Fund – Riverland Park Acquisition - \$700,000

### Abandonment of the Riverland Annexation Road Restoration Project

On April 25, 2017, the Broward County Commission agreed to amend an annexation agreement from 2002 between Broward County and the City of Fort Lauderdale that allows the City to use already received monies from the County for the purpose of land acquisition for public park use.

Staff recommends that the City Commission amend the FY 2017 Community Investment Plan in the amount of \$700,000 for the acquisition of Riverland Park.

#### **City Attorney's Office**

T. Transfer of Funds – General Fund, General Capital Projects Fund – 7<sup>th</sup> Floor Renovation Project - \$148,213

To improve space allocation on the 7<sup>th</sup> floor of City Hall for the City Manager, City Clerk, and City Attorney's staff, renovations are required. The proposed renovations include the demolition and reconfiguration of the existing layout and will incorporate green building technology. The renovations will include the following items:

- Remodeling interiors to be ADA (Americans with Disabilities Act) accessible in accordance with Florida Building Code 2014 Edition;
- Interior layout changes to accommodate new space requirements;
- Lobby remodeling;
- Air-conditioning and electrical modifications;
- Interior finishes upgrades;
- Upgrading the existing Law Library for the best and highest use by removing the
  existing book shelves, providing a media wall, and a conference table for 12
  participants;
- Upgrading existing kitchen to include new millwork.

The estimated scope for construction, contingencies and furniture for this project is estimated to be \$580,000. Of this, \$33,000 is available in an existing 7<sup>th</sup> floor renovation project and \$148,213 is available in the City Attorney's Office FY 2017 operating budget for the City Attorney's Office's portion of the project.

The remaining \$398,787 for this project is recommended for approval with the FY 2018 Community Investment Plan adoption on September 13, 2017 including \$148,213 currently in the FY 2018 City Attorney's Office proposed operating budget.

Staff recommends that the City Commission amend the FY 2017 Budget and Community Investment Plan in the amount of \$148,213 for the City Attorney's Office's portion of the 7<sup>th</sup> Floor Renovation project.

Where applicable, the approval of companion agenda items is contingent upon the approval of the respective companion items as part of this consolidated budget amendment.

A. Transfer Between Capital Projects and Operating Funds - Parking Fund, Arts and Science District Garage Fund – Downtown Wayfinding and Information Signage – \$513,511.48.
