**TITLE:** Resolution to Approve Performing Arts Center Authority Budget and  
Tri-Party Grant Agreement for Fiscal Year 2018

---

**Recommendation**

It is recommended that the City Commission adopt a resolution approving the budget of the Performing Arts Center Authority (PACA) for Fiscal Year 2018 (FY 18) and authorizing the execution of a Tri-Party Grant Agreement related to funding of the Performing Arts Center.

**Background**

In accordance with its enabling act, Chapter 2005-335 Laws of Florida, PACA has presented its adopted budget for FY 18 (Exhibit 2) to the City Commission for approval. The City and County agree to provide financial assistance to PACA as accounted for in the budget under other local grants. Staff requests that the City Commission approve a Tri-Party Grant Agreement with PACA and Broward County governing the provision of this funding.

The City's responsibility under the agreement includes a cash contribution from the net garage revenues of the Arts & Science District Parking Garage to be remitted monthly in an amount not to exceed \$300,000 annually. The City agrees to provide in-kind landscape maintenance services having a value of at least \$30,000 annually, as well as reimburse PACA for any expenses paid for waste removal performed during the contract term in an amount not to exceed \$24,000. The agreement provides the method of payment and other details necessary to implement the terms of the agreement which covers the period of October 1, 2017 through September 30, 2018.

**Resource Impact**

Funds for this agreement in the amount of \$354,000 are available per the FY 18 budget in the accounts listed below:
