A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DEDICATING IN FEE SIMPLE AS PUBLIC RIGHT OF WAY CERTAIN PORTIONS OF CITY OWNED **LANDS** MORE PARTICULARLY DESCRIBED BELOW: SAID DEDICATION SHALL BE SUBJECT TO CERTAIN TERMS AND CONDITIONS **HEREINAFTER** SET FORTH: **ACCEPTING** SUCH DEDICATION; DIRECTING THE CITY CLERK TO RECORD A CERTIFIED COPY OF THIS RESOLUTION IN THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA: REPEALING ANY AND ALL RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Downtown Mobility HUD project, a collaborative effort between the City of Fort Lauderdale, Broward Metropolitan Planning Organization and the United States Department of Transportation/Federal Transit Administration, is a capital project that includes making significant streetscape improvements on the City's Right-of-Way; and

WHEREAS, NW First Street lying between Andrews Avenue and Brickell Avenue is owned by the City but was never dedicated as a public Right of Way; and

WHEREAS, it is recommended that the City Commission adopt a resolution to dedicate NW First Street lying between Andrews Avenue and Brickell Avenue as public right-of-way and accept such dedication to be held in trust for the public;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale hereby dedicates in fee simple the below described lands to be used as a public right-of-way, subject to the terms and conditions hereinafter set forth. By adoption hereof, the City Commission furthermore accepts such dedication to be held in trust for the public. The foregoing lands being dedicated are more fully described below:






