TITLE: Motion to Approve Purchase of Emergency Medical Supplies - Broward

Sheriff's Office - \$450,000

Recommendation

It is recommended that the City Commission approve the purchase of emergency medical supplies from the Broward Sheriff's Office (BSO) in the amount of \$450,000.

Background

Fort Lauderdale is one of more than 20 municipalities purchasing medical supplies and equipment through the BSO's County Regional Logistics Division. This consolidated purchasing power offers cost savings in comparison to a smaller, independent purchasing process.

The Fire Rescue Department believes purchasing medical supplies and equipment through BSO's Regional Logistics division is the Department's best option and thereby requests the City Commission to approve the expenditure for this purchase.

Pursuant to Section 2-176(e)(3), Code of Ordinances of the City of Fort Lauderdale, Florida, purchases from other public entities may be made without competitive solicitation and selection processes.

Resource Impact

There will be a current fiscal impact to the City in the amount of \$450,000.
