ORDINANCE NO. C-17-36

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING SECTION 47-20.3. – "REDUCTIONS AND EXEMPTIONS" OF THE CITY OF FORT LAUDERDALE, FLORIDA UNIFIED LAND DEVELOPMENT REGULATIONS, TO AMEND EXISTING SUBSECTIONS TO REVISE THE REVIEW PROCESS TO INCLUDE THE CENTRAL CITY COMMUNITY REDEVELOPMENT AREA; PROVIDING FOR SEVERABILITY; REPEAL OF CONFLICTING ORDINANCE PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission of the City of Fort Lauderdale, Florida, desires to amend the City of Fort Lauderdale Unified Land Development Regulations ("ULDR"), specifically Section 47-20.3 entitled "Reductions and exemptions"; and

WHEREAS, the Planning and Zoning Board, acting as the local planning agency, at its meeting of August 19, 2017, (PZ Case T17004) found that the proposed text amendments are consistent with the City's Comprehensive Plan and as the Planning and Zoning Board, did recommend to the City Commission that the amendment to the ULDR is consistent with the City of Fort Lauderdale Comprehensive Plan; and

WHEREAS, notice was provided to the public that this ordinance would be considered at the City Commission meeting to be held on Tuesday, September 19, 2017, and Tuesday, October 3, 2017, at 6:00 o'clock P.M., in the City Commission Room, City Hall, Fort Lauderdale, Florida; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That Section 47-20.3.A. General parking reduction, of the City of Fort Lauderdale, Florida ULDR is hereby amended to read as follows:

CODING: Words, symbols, and letters stricken are deletions; words, symbols, and letters underlined are additions.

4. Review Process

- a. Except as provided in subsection b., the application shall be reviewed in accordance with the review process applicable to a site plan level III, as provided in Section 47-24.2.
- b. An application for a parking reduction on property located within the Northwest-Progresso-Flagler Heights Community Redevelopment Area as defined in Resolution No. 95-86 as may be amended, adopted on June 20, 1995, or on property with non-residential zoning located within the Central City Community Redevelopment Area, shall require Site Plan Level I Happroval as provided in Section 47-24.2.

<u>SECTION 2</u>. That Section 47-20.3.F. Northwest-Progresso-Flagler Heights Community Redevelopment Area, of the City of Fort Lauderdale, Florida ULDR is hereby amended to read as follows:

F. Northwest-Progresso-Flagler Heights Community Redevelopment Area and Central City Community Redevelopment Area. The number of Required parking spaces for development within the Northwest-Progresso-Flagler Heights Community Redevelopment Area and abutting non-residential properties located within the Central City Community Redevelopment Area, may be reduced by the number of on-street parking spaces provided in accordance with the following criteria:

<u>SECTION 3</u>. That if any clause, section or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

<u>SECTION 4</u>. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed.
