A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, IN SUPPORT OF THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO MANAGE, CONSTRUCT AND DELIVER THE CORDOVA ROAD COMPLETE STREETS PROJECT IN ACCORDANCE WITH THE FDOT PROGRAM BULLETIN 15-03 REGARDING PROJECTS NOT ON A ROADWAY WITHIN THE STATE HIGHWAY SYSTEM WITHIN THE LOCAL AGENCY'S RIGHTOF-WAY/LOCAL JURISDICTION AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale City Commission approved the submission of an application to the Broward Metropolitan Planning Organization (MPO) through their Transportation Alternatives Program (TAP) program for the Cordova Road Complete Streets Project on January 21, 2015; and

WHEREAS, the total project cost estimate is \$1.3 million for design and construction to be fully funded through the grant according to the draft FY19-23 FDOT Work Program for the project that will include traffic calming, raised intersections and crosswalks, pedestrian lighting, ADA curb ramps; and

WHEREAS, the City of Fort Lauderdale City Commission endorses the Cordova Road Complete Streets Project (FM# 438281.1) to receive funding from the MPO; and

WHEREAS, the Florida Department of Transportation (FDOT) is authorized by Florida Statutes and Federal funding provisions, to allow for managing and constructing off-system projects prioritized in its Five-Year Adopted Work Program for efficiency, innovation, cost and/or time savings which may optimize project delivery; and

WHEREAS, the City of Fort Lauderdale City Commission endorses FDOT delivering the Cordova Road Complete Streets Project on the City's behalf, through the project management of the design and construction phases of the project; and

WHEREAS, the project will be designed in accordance with Fort Lauderdale's CSLIP application scope for a local street that was developed based on the neighborhood's vision, Florida Greenbook, and constructed per FDOT specifications; and

WHEREAS, the City of Fort Lauderdale endorses the Florida Department of Transportation to deliver the project within the City's right of way jurisdiction; and

WHEREAS, it is the responsibility of the City of Fort Lauderdale to maintain or coordinate the maintenance of the roadways after the project's completion;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale, Florida hereby supports the Florida Department of Transportation to deliver the Cordova Road Complete Streets Project through the project management of the design of the project.
