




4.2.4 – Approach to Scope of Work

Fisher Auction Company ("Fisher") proposes to conduct live absolute public vehicle and equipment auctions for the City of Fort Lauderdale per the requirements specified in Bid 875-12011. It would be the intent of Fisher to conduct regularly scheduled quarterly auctions at a site located at 2001 N State Road 7 in Hollywood, Florida. In addition, Fisher would also have the ability to schedule an auction at any other time that would be best suited to perform timely services for the City of Fort Lauderdale ("City"). Fisher will advertise the auctions to retail consumer users, vehicle and equipment dealers and exporters via local papers, auction trade journals, used equipment and vehicle websites and send a direct mail piece to its buyer databases. Brochures will also be sent to the City for distribution.

The auctions will be scheduled on Saturdays which gives all potential bidders a sufficient opportunity to participate. All vehicles and equipment will be paid for in full on auction day and removal will take place within 24 hours of the auction. All bidders will pre-qualify with a \$100.00 refundable cash deposit and show proof of identification for registration purposes. An off-duty police officer will be present on auction day for security. A licensed automobile tag agency will be onsite to ensure that all titles are transferred properly to the buying public. In addition, there will staff on hand to start the vehicles for inspection two hours prior to the commencement of the auction.

Transport of City vehicles and equipment will be conducted by subcontractor Competition Towing and Transport and will be scheduled with the City Contract Coordinator or designees. The vehicles and equipment will be organized on the auction lot by type and similarity.

Fisher Auction Company will provide detailed reports to the City immediately following each auction which will include the description of the item sold and track by lot number, bidder information and sales price. Taxes will be collected accordingly. Fisher will lot each vehicle as it is delivered to the auction site by the contracted tow company. Fisher will provide a full staff on auction day including registration and check-out personnel, auctioneer, bid assistants, and computer operators.

The auction site is located at 2001 N. State Road 7 in Hollywood, Florida 33021. It has access off of N. State Road 7 and W Park Road. The site is $1.85\pm$ acres and has a $1,643\pm$ SF office with restrooms.

Fisher Auction Company currently holds municipal surplus auctions for the Cities of Miami, Miami Beach, Lighthouse Point and the Town of Davie. Our schedule will permit us to allow regular auctions for the City of Fort Lauderdale without interference.




