**TITLE**: Resolution Approving a Dock Use Agreement with Atlantic Beach Clubs-

Two, Inc., from November 1, 2017 to October 31, 2018 and Authorize the

City Manager to execute on behalf of the City

### Recommendation

It is recommended that the City Commission adopt a resolution approving a Dock Use Agreement with Atlantic Beach Clubs-Two, Inc., for the premises known as Dock Areas "A" and "B" and a street address of 1001 Seabreeze Boulevard, Fort Lauderdale from November 1, 2017 to October 31, 2018 and authorize the City Manager to execute on behalf of the City.

## **Background**

Atlantic Beach Clubs-Two, Inc., is located at 1033 Northeast 17<sup>th</sup> Way, Unit 704, Fort Lauderdale Florida. The lease provides a guarantee for dockage rental of 7 slips and associated parking at Dock Areas "A" and "B" located at 1001 Seabreeze Boulevard, Fort Lauderdale.

The rental rate for the dock space will be \$155,000.04 per year plus applicable taxes payable in twelve equal monthly installments of \$12,916.67. The agreement also requires Atlantic Beach Clubs-Two, Inc., to reimburse the City for the cost of shore-side electric.

The lease may be canceled with thirty (30) days written notice for convenience and on five (5) days written notice for cause. The lease continues to impose policy prohibitions regarding the berthing of vessels used for gambling, all forms of adult entertainment, and/or any use determined by the Supervisor of Marine Facilities to be inconsistent with the promoting the facility use as a family oriented recreational City amenity and a tourist attraction. The lease is attached as Exhibit 1.

#### **Resource Impact**

There is a positive fiscal impact to the City will be \$155,000.04 for FY18.
