TITLE:	Motion to Approve Contract for Purchase of Turf Grass Maintenance - VisualScape, Inc \$165,261.90

## **Recommendation**

It is recommended that the City Commission approve a one-year contract, in substantially the form attached, with VisualScape, Inc. for the purchase of turf grass maintenance services in the estimated amount of \$165,261.90 annually; and authorize the City Manager to approve three, one-year renewal options contingent upon appropriation of funds.

#### **Background**

The Parks and Recreation Department is requesting approval of a one-year contract to provide turf grass maintenance which includes mowing, weeding and hedge trimming at various locations. VisualScape was selected as the number one proposer based on their staffing, experience, references and customer-centric approach to service.

The solicitation process consisted of the following:

- August 30, 2017 Request for Proposal (RFP) 12044-885 was issued for Turf Grass Maintenance – fire, parking, and utility service areas.
- October 24, 2017 The RFP closed with a total of five firms submitting proposals:
  - C & M Landscaping, Inc.
  - Royal Regions Inc.
  - Superior Landscaping & Lawn Service, Inc.
  - VisualScape, Inc.
  - Weed-A-Way, Inc.
- November 7, 2017 The evaluation committee consisting of Brian Dooling, Parks Supervisor; Yoly Colaruso, Parks Supervisor; and William McDonough, Parks Supervisor - met with Laurie Platkin, Procurement Specialist II, to evaluate and rank the firms based on the evaluation criteria shown below:

EVALUATION CRITERIA	WEIGHT
Understands the scope of the project	20%
Meets technical specifications	10%
References, past performances, years in business	40%
Total Project Cost	30%
Total	100%

The five firms were ranked as follows:

- 1. VisualScape, Inc.
- 2. Superior Landscaping & Lawn Service, Inc.
- 3. C & M Landscaping, Inc.
- 4. Weed-A-Way, Inc.
- 5. Royal Regions Inc.

The committee recommends award to the top ranked proposer, VisualScape, Inc., as meeting all requirements of the RFP specifications.

## Resource Impact

There will be a current fiscal year impact in the amount of \$165,261.60. Funds for this purchase are available in the FY 2018 Budget in the accounts listed below.
