TITLE: Motion to Approve Cooperative Contract for Rental of Vehicles and Use of
Law Enforcement Trust Funds – Enterprise Leasing Company of Florida,
LLC – \$502,320 (estimated two-year total)

Recommendation

It is recommended that the City Commission approve a two-year contract, in substantially the form attached, to rent unmarked police vehicles via City of Coral Springs Contract 17-C-053 from Enterprise Leasing Company of Florida, LLC (Enterprise); utilize the Law Enforcement Trust Funds (LETf) in the estimated two-year total of \$502,320; and authorize the City Manager to approve two additional one-year extensions.

Background

The Police Department's Street Crimes and Special Investigations Divisions require the use of a variety of vehicles to avoid detection while conducting covert investigations. Enterprise is willing to accommodate requests for deployment of a variety of vehicles for short to extended periods of time without incurring additional costs.

Pursuant to Section 2-181(f)(5)(a), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may purchase from any cooperative contract provided that it is established in compliance with the procurement procedures and requirements of the issuing body, entity, authority, or cooperative.

Resource Impact

There will be a current fiscal year impact to the City in the amount of \$251,160. These funds are available in the accounts listed below.
