Presentation Celebrating the 56th Anniversary of Official Sister City Relationship between the City of Fort Lauderdale, Florida and the City of Medellin, Colombia

Marianne Winfield, Executive Director, Greater Fort Lauderdale Sister Cities, gave a brief history of the Sister Cities Program established and founded in 1956 by President Eisenhower with the intention of getting to know people around the world. Ms. Winfield commented on its history and 56th Anniversary of the Sister City Relationship between the City of Fort Lauderdale and the City of Medellin, Colombia.

Ms. Winfield introduced a video greeting from Mayor Gutierrez, City of Medellin, which was shown to the audience. Mayor Seiler commented on his visit last year to Medellin.

Ms. Winfield introduced Anthony Abbate, Associate Provost, Florida Atlantic University (FAU). Mr. Abbate gave a PowerPoint presentation on the collaboration between FAU/Universidad Nacional de Colombia and the recently signed Memorandum of Understanding between these Universities to explore common concerns and future cooperation. He thanked the Mayor and Commission for inviting FAU to explore these opportunities.

Ms. Winfield introduced Fernando Gill of Greater Fort Lauderdale Sister Cities International. In response to Commissioner Trantalis' questions regarding item A., City Manager Feldman explained that it appropriates and transfers funds from the Parking Fund for the Barefoot Contessa Land Swap Agreement. The site is for the future development of a public parking lot. The transfer of funds is for closing costs, appropriates revenues and expenditures associated with the transaction to account for this asset. City Manager Feldman further expounded on accounting aspects involved in this transaction.

Commissioner Rogers commented on residual funds in the South Side School Cultural Arts Center (South Side School) account. City Manager Feldman announced the ribbon cutting for South Side School would be in conjunction with the State of the City Address in January 2018.

In response to Commissioner Trantalis' questions regarding item J., City Manager Feldman explained the budget amendment allows expenditure of the remaining special obligation bond proceeds on eligible projects and closing of the bond. City Manager Feldman said this is a permitted use of the bond funds. City Auditor Herbst confirmed the governing body can determine other bond eligible expenses, stating these projects into capital expenditures and the long-term category of municipal projects.

Commissioner Trantalis commented on the allocation to address the Coconut Isle Bridge (Bridge) and the need to augment this allocation for street repairs and flooding concerns in this area. City Manager Feldman said this allocation is Bridge specific. The road and flooding aspect is part of the Stormwater Master Plan. Commissioner Trantalis expounded on the need to address necessary repairs to streets impacted by flooding.

Mayor Seiler recognized Alan Dodd, Deputy Director of Public Works,

who confirmed the Coconut Isle road impacted by flooding is in need of being milled and paved. He discussed the annual budget for road repairs, stating other roads are higher on the list for needed of critical repair. Commissioner Trantalis commented on the need to increase 2018 funding for road repairs. Further discussions ensued on the amount allocated in 2018 for road repairs, types of road repairs and the need to correct underlying issues.

Mayor Seiler recognized former Commissioner Charlotte Rodstrom, 66 Nurmi Drive. In response to Commissioner Rodstrom's question about the timeline for the Bridge, Mayor Seiler stated it will begin when state approval is received regarding the Bridge's historic designation.

In response to Commissioner Rodstrom's inquiry regarding item E., appropriation of unanticipated revenue and expenditure from the General Fund to the Police Pension Plan, City Manager Feldman explained more funding was received from the state and it is required to be appropriated to the Police Pension Plan. The higher contribution from the state is based upon insurance policies sold within the City.

Mayor Seiler recognized Charles King, 105 N. Victoria Park Road. Mr. King commented on the need to prioritize spending and focus on needs such as flooding. He also commented on tax increases on property owners.

Commissioner Trantalis introduced this Resolution which was read by title only.

Mayor Seiler recognized Charles King, 105 N. Victoria Park Road. Mr. King commented on the need to prioritize spending. Commissioner Trantalis commented on his concern regarding this item, confirming he could not support this item.
