TITLE:	Motion to Approve Purchase of Mulch through Southeast Florida Governmental Purchasing Cooperative Contract - \$205,000	

Recommendation

It is recommended that the City Commission approve the purchase of mulch through the Southeast Florida Governmental Purchasing Cooperative (Co-op) Contract No. E-42-17 in the estimated one-year total of \$205,000 from various vendors and authorize the City Manager or designee to approve renewal options coterminous with the Co-Op contract, contingent upon approval and appropriation of funds.

Background

This is a Co-op contract with the City of Pompano Beach acting as lead agency. The City of Fort Lauderdale (along with 26 other municipalities) anticipates purchasing from this contract. The products contained in this bid were determined by participating agency members and represents products used by the majority of the cooperative purchasing group.

The awarded vendors will supply mulch for all areas maintained by the Parks and Recreation Department, including all athletic fields and parks, the beach, improved medians, entranceways, fire stations, City-owned buildings and open spaces. The awarded vendors are as follows:

a.	Advanced Mulch, Inc.	– Item 9
b.	Adwood, Inc.	– Items 1, 2, 6, 12
C.	East Coast Mulch	– Items 8, 10, 11, 13
d.	Superior Mulch	– Items 3, 4, 5, 14

Pursuant to Section 2-181(f)(5)(a), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may purchase from any cooperative contract provided that the cooperative contract is established in compliance with the procurement procedures and requirements of the issuing body, entity, authority, or cooperative.

Resource Impact

There will be a current fiscal impact to the City in the amount of \$205,000.
