

RESOLUTION NO. 17-287

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION NO. 17-198, AMENDED BY RESOLUTION NO. 17-243, AMENDING THE ADOPTED FISCAL YEAR 2018 NUISANCE ABATEMENT ROLL.
