TITLE: Motion to Approve Increase in Expenditures to Contract for Roll-off

Dumpster Services – A. J. Panzarella L.L.C. - \$131,000

Recommendation

It is recommended that the City Commission approve additional expenditures to the existing contract with A.J. Panzarella L.L.C. (Panzarella) #343-11406 for roll-off dumpster services in the amount of \$131,000.

Background

On June 3, 2014, the City Commission approved a three-year contract with two, one-year renewal options with Panzarella for the purchase of roll-off dumpster services in the annual amount of \$197,185.14 (CAM 14-0647). The contract encompasses both the hauling of the dumpsters and pass-through costs related to disposal fees.

The City has increased its use of this contract for the Public Works Department stormwater operations to meet the need for hauling street sweeping and vacuum truck silts which were formerly hauled by City staff and equipment. Using an external hauler allows City staff and equipment to be deployed in addressing infrastructure maintenance and other service needs, providing an improvement in service delivery. A substantial portion of the increase in the contract is related to disposal fees associated with the hauled silts.

This action will address the immediate operational need by increasing the allowable expenditures and utilizing our current roll-off services contract. Roll-off services for stormwater operations will be competitively procured later this fiscal year.

Resource Impact

There will be a fiscal impact to the City in the estimated amount of \$131,000. Funds for this purchase in the amount of \$131,000 are available in the FY 2018 operating budget accounts listed.
