TITLE:	Motion to Approve Correction of Award Amount to Contract for Vehicle Graphics, Installation and Removal – Graphic Designs International, Inc. – \$399,972

Recommendation

It is recommended that the City Commission approve a correction to the award amount of \$133,324 to Graphic Designs International, Inc. for the purchase, removal, and installation of vehicle graphics, and increase the value by \$266,648 for a revised three-year contract amount of \$399,972.

Background

On September 7, 2016, the City Commission approved a three-year contract for vehicles graphics, installation and removal with a value of \$133,324 (CAM 16-0879). The solicitation, ITB 863-11794, was written and priced annually; therefore, the original CAM should have specified the total cost for a three-year contract to be in the estimated amount of \$399,972 rather than the original requested annual amount of \$133,324. The additional amount of \$266,648 will enable the City to continue to receive the necessary services through the remainder of the contract term which expires on November 6, 2019.

Resource Impact

Funds for this purchase in the amount of \$133,324 are available in the FY 2018 operating budget account listed below. Future expenditures are contingent upon adoption of subsequent fiscal year budgets.
