TITLE: Motion Approving an Application for a Temporary Beach License and

Outdoor Event Agreement with AIDS Healthcare Foundation, Inc. for a 5k

and Music Event on Fort Lauderdale Beach

Recommendation

It is recommended that the City Commission approve an application for a temporary beach license and outdoor event agreement and authorize the City Manager to execute the agreement on behalf of the City of Fort Lauderdale with Aids Healthcare Foundation, Inc. for the 2018 Florida AIDS Walk & Music Festival on Sunday, March 18, 2018. Authorization for the execution of Event Agreements is contingent upon the City Attorney's Office receiving and approving a validly executed agreement.

Background

The Parks and Recreation Department has received a request from the AIDS Healthcare Foundation for the 2018 Florida AIDS Walk & Music Festival to be held on Sunday, March 18, 2018 on Fort Lauderdale Beach. Estimated attendance for this event is approximately 7,500 people.

This event has been held on Fort Lauderdale Beach since 2012 and is aimed at promoting fundraising and awareness. The post walk concert will feature major musical acts playing on stage at the beach.

City staff has been working closely with the event organizer regarding event topics such as logistics, maintenance, and security as detailed below. Amplified music was discussed and the event organizer was advised of the noise ordinance and possible concerns.

The event organizer will pay for all event costs and submit the required certificates of insurance. The agreement provides that the organizer will pay \$500 for each event use of the beach. The event organizer will secure all other necessary permits and licenses that are required from other agencies. Civic and merchant associations have been

notified as appropriate regarding the event. Event details are included in the event application as attached.
