TITLE:	Quasi-Judicial Resolution Granting a Waiver of Limitations at 1325 East Lake Drive for the Installation of a Floating Dock and Access Ramp

### **Recommendation**

It is recommended that the City Commission adopt a Resolution granting a Waiver of Limitations for the installation of a floating dock and access ramp.

### **Background**

The applicant is seeking a resolution granting a Waiver of Limitations (a waiver to allow mooring structures to extend beyond the maximum distance as defined by City Code) of Section 47-19.3 (D) of the Unified Land Development Regulations (ULDR) for the installation of a floating dock and access ramp extending a maximum distance of +/-45 feet from the property line into Sylvan Lake.

The summary description specifies that the additional distance for the floating dock and access ramp are necessary to safely access resident's vessel from the stern, offloading vessels on the lift, and for the safe launching of paddleboards.

Although there is not a fee associated with obtaining a Waiver of Limitations, an application fee in the amount of \$300.00 is required.

The MAB recommended approval of the application 10 to 1 (see Exhibit 3).

# Resource Impact

There is a positive fiscal impact in the amount of \$300 revenue.
