A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DEDICATING A 77-FOOT WIDE PUBLIC RIGHT OF WAY EASEMENT FOR SE STREET BETWEEN STATE ROAD A1A SEABREEZE BOULEVARD OVER A PARCEL OF CITY OWNED LAND LOCATED IN THE PLAT OF "LAS OLAS BY THE SEA," RECORDED AT PLAT BOOK 1, PAGE 16 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA, PARTICULARLY **BELOW: DESCRIBED** MORE DEDICATION SHALL BE SUBJECT TO CERTAIN TERMS AND CONDITIONS HEREINAFTER SET FORTH: ACCEPTING SUCH DEDICATION; DIRECTING THE CITY CLERK TO RECORD A CERTIFIED COPY OF THIS RESOLUTION IN THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA; REPEALING ANY AND ALL RESOLUTIONS IN CONFLICT: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, SE 5th Street has historically been used and treated as a local road by adjacent businesses and the general traveling public and facilitates local traffic circulation and access of the area of the barrier island by providing a one-way westbound connection between southbound SeaBreeze Boulevard and northbound State Road A1A; and

WHEREAS, dedication of certain City-owned property described below as municipal right-of-way and acceptance of the dedication is deemed to be in the best public interest; and

WHEREAS, it is recommended that the City Commission adopt a resolution to dedicate a parcel of City-owned property as public right-of-way and accept such dedication to be held in trust for the public;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale hereby dedicates in fee simple the below described land to be used as a public right-of-way, subject to the terms and conditions hereinafter set forth.
