<u>SECTION 1</u>. Pursuant to Section 163.380(3)(a), Florida Statutes, a Notice of Intent to Dispose of Fort Lauderdale Community Redevelopment Agency Property for the Development of Vacant Real Property located at 835 NW 3rd Street in the Northwest-Progresso-Flagler Heights Community Redevelopment Area was published in the Sun-Sentinel on January 3, 2018. The notice provided that all proposals were due at the CRA Office on or before 4:00 p.m. on February 5, 2018.

<u>SECTION 2</u>. The Board of Commissioners of Fort Lauderdale Community Redevelopment Agency hereby accepts the offer from 220145 LLC as set forth on the proposal dated February 2, 2018, presented by Lansing Melbourne Group LLC on behalf of 220145 LLC. That the Executive Director shall execute the Commercial Contract and Addendum, in substantially the form attached, (hereinafter, "Contract"). Authority to execute any other instruments reasonably necessary or incidental to the sale and conveyance of the Property under the Contract is hereby delegated to the Executive Director.
