TITLE: Motion to Approve Contract for Fort Lauderdale Executive Airport South

Perimeter Loop Road – Florida Blacktop, Inc. - \$358,937

Recommendation

It is recommended that the City Commission approve a contract, in substantially the form attached, for the Fort Lauderdale Executive Airport (FXE) South Perimeter Loop Road Project with Florida Blacktop, Inc. in the amount of \$358,937.

Background

Currently, vehicles and aircraft on the north side of the airport have to cross Runway 31 in order to relocate the aircraft/equipment to the areas south of the Runway. These crossings affect the tower operations, airfield traffic, and increase the possibility of unauthorized incursions. An asphalt perimeter road will be constructed along the southeastern end of Runway 31 to minimize runway crossings, and to enhance the safety of airport operations. The work includes existing millings road demolition, subgrade, limerock and asphalt paving, grading, pavement striping, sodding, watering period, lighting and electrical works.

On December 19, 2017, the Procurement Services Division issued Invitation to Bid No. 12029-683. Five bids were received on January 30, 2018, and all bids were reviewed for compliance with the solicitation specifications. The bid submitted by Florida Blacktop, Inc. has met all of the specifications of the solicitation and has been deemed the lowest cost, responsive, and responsible bid.

Resource Impact

There will be a fiscal impact to the City in the amount of \$358,937 for the contract award and \$17,950 for estimated in-house project management fees for a total of \$376,887. Funds for this purchase in the total amount of \$376,887 are available in the FY 2018 Community Investment Plan in the accounts listed below:
