TITLE: Motion to Approve Addendum to Terminate Agreement with SunGard
Public Sector Inc. for the Purchase of ONESolution Products

Recommendation

It is recommended that the City Commission terminate the agreement Number 2677LG-121339-1 between the City and SunGard Public Sector Inc. for the purchase of the ONESolution products to upgrade the existing CommunityPlus software; and approve and authorize execution of the Addendum Assigning and Terminating Application Services Provider Agreement, Number 2677LG-121339-1, between the City of Fort Lauderdale and Sungard Public Sector Inc. in substantially the form attached (Exhibit 2).

Background

On February 19, 2013, the City of Fort Lauderdale approved entering into agreement with SunGard Public Sector Inc. to purchase an upgrade to the CommunityPlus software used by Sustainable Development, Police, Fire and Finance Departments for building permits, development review, community compliance, alarm billing and business tax. The ONESolution product was deemed incapable of being successfully migrated from CommunityPlus since the data could not be fully converted to function in the ONESolution products.

SunGard Public Sector was acquired by Superion, formerly known as Ramundsen Public Sector, subsequent to the signing of the original agreement with SunGard. The City is still utilizing the CommunityPlus product until such time the transition to Accela is completed and the City also utilizes another Superion product for police records management through an agreement with the County regionalization for dispatch services. Due to the continued use of Superion products, the costs expended by the City for the ONESolution product will be offset in the form of credits for the remaining products in use.

Staff recommends that the City Commission approve the addendum to terminate the ONESolution agreement since the Accela product has now been chosen to replace the CommunityPlus product.

Resource Impact

There is no current year fiscal impact.
