**TITLE:** Resolution to Amend the Adopted Fiscal Year 2018 Nuisance Abatement  
Roll

**Recommendation**

It is recommended that the City Commission amend the non-ad valorem assessment roll for nuisance abatement to correct the assessed costs for several properties.

**Background**

At the September 13, 2017 City Commission meeting, the City Commission adopted the Non-Ad Valorem Nuisance Abatement Assessment Roll for Fiscal Year 2018. The assessment roll established the non-ad valorem assessment for the recovery of unpaid expenses and administrative costs incurred by the City to abate identified nuisances. The adopted assessment roll was certified by the Broward County Tax Collector to be collected on annual tax bills.

The properties listed in Exhibit 1 received assessments that need to be removed from the assessment roll because the payment was received or because of an error in the assessment. Exhibit 2 includes the details prompting the removal of the property from the assessment roll. If the resolution in Exhibit 3 is approved, the tax collector will remove the assessments listed in Exhibit 1 from the tax bill, ensuring these properties do not receive a tax certificate.

The Nuisance Assessment Roll adopted at the September 13, 2017 City Commission Meeting estimated generation of \$540,197 in revenue. With the removal of the aforementioned properties, the assessment would generate \$470,485.
