## **RESOLUTION NO. 18-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, APPROVING A ROADWAY TRANSFER AGREEMENT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE A ROADWAY TRANSFER AGREEMENT WITH FLORIDA DEPARTMENT OF TRANSPORTATION FOR THE TRANSFER OF OWNERSHIP OF CERTAIN SECTIONS OF LAS OLAS BOULEVARD/SR842, LESS AND EXCEPT THE DWIGHT L. ROGERS MEMORIAL BRIDGE AND CERTAIN INTERSECTIONS, TO CITY-OWNED PUBLIC RIGHT-OF-WAY, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Fort Lauderdale Community Redevelopment Agency is redesigning certain sections of Las Olas Blvd.; and

WHEREAS, Las Olas Blvd. is a state owned road and the design elements under the City's vision for Las Olas Blvd. do not meet the design standards of the State of Florida, Department of Transportation; and

WHEREAS, as a condition to redesigning the road, FDOT requires the City to accept ownership and maintenance of certain sections of Las Olas Blvd (as described in the Roadway Transfer Area), less and except the Dwight L. Rogers Memorial Bridge and certain intersections, subject to certain terms and conditions, as described in the Roadway Transfer Agreement; and

WHEREAS, the Roadway Transfer Agreement includes taking ownership of the pavement, sidewalks, storm drain system, canal bridge and sea walls but excludes the Dwight L. Rogers Memorial Bridge and certain intersections; and

WHEREAS, the City will maintain ownership of Las Olas Boulevard between downtown Fort Lauderdale and the beach and FDOT will maintain ownership of A1A/Seabreeze Boulevard Intersection, A1A/Fort Lauderdale Beach Boulevard intersection and the Dwight L. Rogers Memorial Bridge.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the above recitals are true and correct and incorporated into this Resolution by this reference.

<u>SECTION 2</u>. That the City Commission of the City of Fort Lauderdale, Florida approves a Roadway Transfer Agreement, attached hereto, between the Florida Department of Transportation ("FDOT") and the City of Fort Lauderdale to transfer ownership of that section of SR842/Las Olas Boulevard as described in the Agreement, less and except the Dwight L. Rogers Memorial Bridge and certain intersections, and hereby authorizes the City Manager to execute the Roadway Transfer Agreement on behalf of the City of Fort Lauderdale.

<u>SECTION 3</u>. That the office of the City Attorney shall review and approve as to form all documents prior to their execution by the City Manager.

SECTION 4. That this Resolution shall be in full force and effect upon final passage.
