TITLE: Motion to Approve Contract for Purchase of Turf Grass Maintenance for

City Quadrants Northwest, Southwest, and Southeast - Multiple Vendors

- \$241,105

Recommendation

It is recommended that the City Commission approve a one-year contract for the purchase of turf grass maintenance for City quadrants northwest, southwest and southeast from multiple vendors in the estimated amount of \$241,105; and authorize the City Manager to approve three, one-year renewal options contingent upon appropriation of funds.

Background

The Parks and Recreation Department is requesting approval of a one-year contract to provide turf grass maintenance, which includes mowing, weeding and hedge trimming for the northwest, southwest, and southeast quadrants spanning various locations throughout the City. The northeast quadrant is currently covered under Contract No. 375-11852 by C&M Landscaping, Inc. (C&M).

On March 5, 2018, the Procurement Services Division issued Invitation to Bid 12116-883 Turf Grass Maintenance for City Quadrants Northwest, Southwest and Southeast and received six bids. Awards will be made by quadrant (as detailed in Exhibit 1) to the lowest bidders that have met all of the specifications of the bid and have been deemed the lowest cost, responsive and responsible bidders.

Award will be made to the following vendors:

- C&M Fort Lauderdale, FL Northwest Quadrant
- Royal Regions Inc. Miami, FL Southwest and Southeast Quadrants
