A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE MANAGER TO REQUEST THE FLORIDA DEPARTMENT OF TRANSPORTATION ("FDOT") TO CONVEY SURPLUS PROPERTY TO THE CITY OF FORT LAUDERDALE ("CITY") TO BE UTILIZED FOR THE PUBLIC PURPOSE AS DETERMINED BY THE CITY: SUCH **PROPERTY** BEING **IDENTIFIED** IN THE LEGAL DESCRIPTION AND SKETCH ATTACHED AS EXHIBIT "A": PROVIDING AN EFFECTIVE DATE: AND FOR OTHER PURPOSES.

WHEREAS, FDOT acquires real property for transportation facilities for the citizens of the State of Florida; and

WHEREAS, FDOT is permitted by law to convey real property that FDOT no longer needs for transportation and is authorized to convey such surplus property to other public entities to further the public needs of the State of Florida; and

WHEREAS, the City is requesting that FDOT convey to the City the surplus property described on Exhibit "A"; and

WHEREAS, the City can utilize FDOT's surplus property described on Exhibit "A"; and

WHEREAS, it is in the best interest of the citizens of the State of Florida to gain the most benefit from properties acquired with public funds.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, THAT:

<u>SECTION 1:</u> The foregoing recitals are true, correct and incorporated into this Resolution by this reference.

<u>SECTION 2:</u> The City requests FDOT to convey title to the surplus property described on Exhibit "A" to the City pursuant to Section 337.25(4)(d), Florida Statutes, provided FDOT can provide clear and marketable title to the property and subject to approval of the City Attorney.

<u>SECTION 3:</u> The surplus property to be conveyed to the City by FDOT will be used for the public purpose as determined by the City.

SECTION 5: ___This Resolution shall take effect immediately upon passage.




