**TITLE:** Motion to Approve Contract for Liquid Chlorine in Rail Cars – Allied  
Universal Corp. – \$364,770

**Recommendation**

It is recommended that the City Commission award a one-year contract, in substantially the form attached, for the purchase of liquid chlorine in rail cars to Allied Universal Corp. in the estimated annual amount of \$364,770; and authorize the City Manager to approve three, one-year renewal options contingent upon appropriation of funds.

**Background**

During the water treatment process, chlorine is added to the finished water which provides a disinfectant residual that is sustained throughout the distribution system. The disinfectant residual must be maintained as per the Florida Department of Health in Broward County and Florida Department of Environmental Protection regulations.

On March 8, 2018 the Procurement Services Division issued Invitation to Bid (ITB) No. 12124-382 and received three responses. The lowest priced bidder MCWDCC Auto Sales & Services Corp did not provide the safety data information and references as part of the ITB's questionnaire and has therefore been deemed non-responsive. Allied Universal Corp. has been deemed the lowest priced, responsive and responsible bidder.

**Resource Impact**

There is an estimated fiscal impact to the City for the current fiscal year in the amount of \$125,000. Funds for this purchase are available in the account listed below. Future annual expenditures totaling \$364,770 are contingent upon adoption of future years' budgets.
