**TITLE:** Motion to Approve Contracts for Motor Rewind Services – Various  
Vendors - \$441,738 (two-year total)

---

**Recommendation**

It is recommended that the City Commission approve two-year contracts, in substantially the forms attached, for the purchase of motor rewind services from Kaman Industrial Technologies Corporation d/b/a Florida Bearings, T A C Armatures & Pumps Corp., and TAW Miami Service Center, Inc. in the estimated, aggregate two-year total of \$441,738; and authorize the City Manager to approve two, one-year renewal options contingent upon approval and appropriation of funds.

**Background**

Public Works Department maintenance staff operates over 200 sanitary sewer pump stations, four stormwater stations, three treatment plants, and 37 raw water supply wells throughout the City. Around-the-clock operations in aggressive atmospheres wear the motors over time. This contract will enable the department to perform the necessary repairs to keep the motorized systems operational.

On March 20, 2018 the City's Procurement Services Division issued Invitation to Bid No. 12127-383 for motor rewind services.

A total of four bids were received from the following vendors:

- Kaman Industrial Technologies Corporation d/b/a Florida Bearings
- T A C Armatures & Pumps Corp.
- TAW Miami Service Center, Inc.
- Condo Electric

Staff recommends awarding the contract on an as-needed basis to the lowest cost, responsive, and responsible bidders per line item to Kaman Industrial Technologies Corporation d/b/a Florida Bearings in the estimated annual amount of \$46,795; TAC Armatures & Pumps Corp. in the estimated annual amount of \$45,657; and TAW Miami Service Center, Inc. in the estimated amount of \$128,417. The fourth bidder, Condo Electric, did not offer any lowest priced line items when compared to the other vendor's prices and was therefore not awarded a contract for these services

### **Resource Impact**

There is an estimated current fiscal year impact in the amount of \$75,000. Funds for this purchase are available in the FY 2018 Budget in the account listed below. Future expenditures are contingent upon adoption of future years' budgets.
