

ORDINANCE NO. C-18-

AN ORDINANCE OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING SCHEDULE I OF THE PAY PLAN OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY CREATING TWO NEW CLASSES, AMENDING SECTION 2 OF ORDINANCE C-18-13 AS CODIFIED IN SECTION 20-83 OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE, FLORIDA, BY DESIGNATING ONE CLASS AS AN ADMINISTRATIVE ASSISTANT TO THE CITY MANAGER, AND PROVIDING FOR SEVERABILITY, REPEAL OF CONFLICTING ORDINANCE PROVISIONS, AND AN EFFECTIVE DATE.

WHEREAS, the City Manager and the Director of Human Resources recommend amending the Pay Plan of the City of Fort Lauderdale, Florida, and amending Section 20-83 of the Code of Ordinances of the City of Fort Lauderdale, Florida,

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That Schedule I of the Pay Plan of the City of Fort Lauderdale, Florida, is amended to create and add in alphabetical order by class title, the following classes:

SECTION 2. That the codified paragraph set forth in Section 2 of Ordinance No. C-18-13 of the City of Fort Lauderdale, Florida, as codified in Section 20-83 of the Code of Ordinances of the City of Fort Lauderdale, Florida, is amended to provide as follows:

The following professional managerial and administrative employees in the office of the city manager are administrative assistants to the city manager: administrative assistant, administrative assistant I, administrative assistant II,

assistant to the city manager, structural innovation manager, budget manager, public affairs manager, neighbor services manager, assistant budget manager, assistant manager of CIP (Community Investment Plan)/Grants, financial management analyst, senior financial management analyst, principal financial analyst, performance analyst, chief service officer, assistant neighbor support manager, assistant structural innovation manager, assistant public affairs manager, professional standards manager, management analyst, senior performance analyst, CRA (Community Redevelopment Agency) administrative specialist, CRA economic development program aide, CRA accounting clerk, CRA administrative aide, CRA project coordinator, CRA housing and economic development assistant, CRA planner, CRA project manager, CRA business manager, CRA senior project manager, CRA housing and economic development manager, nighttime economy manager, ~~and~~ housing and community development program manager, and executive assistant to the city manager.

SECTION 3. That if any clause, section, or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.

SECTION 4. That all ordinances or parts of ordinances in conflict herewith, be and the same are hereby repealed.

SECTION 5. That this Ordinance shall be in full force and effect immediately upon its final passage.
