A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AMENDING RESOLUTION NO. 18-72 TO RESCHEDULE THE PUBLIC HEARING BEFORE THE CITY COMMISSION FROM TUESDAY, JUNE 19, 2018 TO TUESDAY, JULY 10, 2018, FOR CONSIDERATION OF THE TERMS OF THE LEASE AND AUTHORIZING EXECUTION OF SAME BY THE PROPER CITY OFFICIALS.

WHEREAS, by Resolution No. 18-38 the Public Hearing was extended to April 17, 2018; and

WHEREAS, by Resolution No. 18-72 the Public Hearing was extended to June 19, 2018; and

WHEREAS, the City Commission has agreed to delay the Public Hearing;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. The Recitals are true and correct and incorporated herein by reference.

<u>SECTION 2</u>. That the Public Hearing scheduled for June 19, 2018 has been delayed until Tuesday, **July 10, 2018** at 6:00 pm, or as soon thereafter as can be heard, or such other date as the City Commission may designate, at City Hall at 100 North Andrews Avenue, Fort Lauderdale, Florida for purpose of reviewing the terms and conditions of the Lease.
