A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, ADDING "DRAGON WAY" AS THE PRIMARY STREET NAME OF THAT SECTION OF "SW 5TH PLACE" LOCATED BETWEEN SW 20TH AVENUE AND SW 16TH **AVENUE** 5TH **DESIGNATING** SW **PLACE** AS THE NAME. DIRECTING THE CITY SECONDARY STREET MANAGER TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION, CLERK TO TRANSMIT DIRECTING THE CITY COPY OF THIS RESOLUTION TO THE BROWARD COUNTY TRAFFIC ENGINEER, DIRECTING THE CITY TRANSMIT CLERK TO COPY OF THIS RESOLUTION TO THE CITY ENGINEER, PROVIDING FOR SEVERABILITY. PROVIDING FOR CONFLICTS. AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Fort Lauderdale, Florida, (the "City") recognizes the significance of Stranahan High School, which was originally founded in 1953 as an elementary school and since 1958 has operated as a High School within the City; and

WHEREAS, Stranahan High School is the second oldest public school in the City and is home to one of the most diverse student populations in Broward County; and

WHEREAS, Stranahan High School has over 1000 students currently enrolled, that commute from all over Broward County to participate in the school's magnet program; and

WHEREAS, Stranahan High School is located on SW 5th Place and the school's mascot is a dragon; and

WHEREAS, the City Commission wishes to recognize Stranahan High School and its contribution to society; and

WHEREAS, the City Commission, with the support of Stranahan High School, wishes to add, "Dragon Way", as the primary street name of a section of SW 5th Place that is located between SW 20th Avenue and SW 16th Avenue and designate SW 5th Place as the secondary street name; and

WHEREAS, the City Commission finds that adding "Dragon Way" as the primary street name is a better way for the City to connect with Stranahan High School and its students, parents, guardians, and faculty;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

- <u>SECTION 1</u>. The forgoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct, and are incorporated herein by this reference.
- <u>SECTION 2</u>. The City Commission hereby adds, "Dragon Way", as the primary street name of that section of "SW 5th Place" located between SW 20th Avenue and SW 16th Avenue and designates SW 5th Place as the secondary street name.
- SECTION 3. The new street sign shall include "Dragon Way" and "SW 5th Place."
- <u>SECTION 4</u>. The City Manager is hereby directed to take any and all appropriate action necessary to effectuate the intent of this resolution.
- <u>SECTION 5</u>. The City Clerk is hereby directed to transmit a copy of this Resolution to the Broward County Traffic Engineer for future inclusion in the Official Map of the City of Fort Lauderdale.
- <u>SECTION 6</u>. The City Clerk is hereby directed to provide a copy of this Resolution to the City Engineer for future inclusion in the official map of the City of Fort Lauderdale.
- <u>SECTION 7</u>. If any section, sentence, clause, or phrase of this resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then the holding shall in no way affect the validity of the remaining portions of this resolution.
- <u>SECTION 8</u>. All resolutions inconsistent or in conflict herewith shall be and are hereby repealed insofar as there is a conflict or inconsistency.
