**TITLE:** Motion to Approve a Dock Use Agreement with Lady Pamela Boat Rentals, LLC from August 1, 2018 to July 31, 2019 and Authorize the City Manager to Execute the Agreement on behalf of the City

## **Recommendation**

It is recommended that the City Commission approve a Dock Use Agreement with Lady Pamela Boat Rentals, LLC for the premises known as Dock Areas "A" and "B" and a street address of 1001 Seabreeze Boulevard, Fort Lauderdale from August 1, 2018 to July 31, 2019 and authorize the City Manager to execute on behalf of the City, subject to receipt of a Termination Agreement from the prior Lessee.

## Background

Lady Pamela Boat Rentals, LLC is located at 905 Coconut Drive, Fort Lauderdale, FL. The lease provides for a guarantee of dockage rental of 7 slips and associated parking at Dock Areas "A" and "B" located at 1001 Seabreeze Boulevard, Fort Lauderdale.

The rental rate for the dock space will be \$155,000.04 per year plus applicable taxes payable in twelve equal monthly installments of \$12,916.67. The agreement also requires Lady Pamela Boat Rentals, LLC to reimburse the City for the cost of shore-side electric.

The lease may be canceled with 30-days written notice for convenience and on five (5) days written notice for cause. The lease continues to impose policy prohibitions regarding the berthing of vessels used for gambling, all forms of adult entertainment, and/or any use determined by the Supervisor of Marine Facilities to be inconsistent with the promotion of the New River Riverwalk as a family oriented; recreational amenity and tourist attraction. The Lease is attached as Exhibit 1.

# Resource Impact

There is a positive fiscal impact to the City will be \$155,000.04. Revenue related to this agreement is included in the FY2018 operating budget in the account listed below:
