**TITLE**: Resolution in Support of the City of Tamarac's Prospect Road Complete

Streets Project

#### Recommendation

It is recommended that the City Commission adopt a resolution in support of the City of Tamarac's Complete Streets and Localized Initiatives Program (CSLIP) application to add bike lanes, sidewalks, and curbs/gutters along Prospect Road between NW 31<sup>st</sup> Avenue and Commercial Boulevard.

## **Background**

The City of Tamarac is seeking funding during the upcoming grant round of the Broward Metropolitan Planning Organization Complete Streets and Localized Initiatives Grant Program (CSLIP). The proposed application includes the installation of bike lanes, sidewalks, and curbs/gutters along Prospect Road between NW 31st Avenue and Commercial Boulevard.

A 205 foot section of Prospect Road, located at the corner of Prospect Road and 31st Avenue, falls within the jurisdiction of the City of Fort Lauderdale. The grant requires that all parties with jurisdiction within the project limits provide resolutions of support in order for the project to be eligible for funding. By approving the resolution, the City indicates its support of Florida Department of Transportation (FDOT) managing the design and construction of the project. Broward County maintains the roadway.

It is the City of Tamarac's desire to finish the bike paths, sidewalks, curbs and gutters to NW 31st Avenue rather than stopping abruptly at the Tamarac city limits. Staff from the City of Tamarac presented the bike lanes concept to the Aviation Advisory Board at its December 7, 2017 meeting, where the Advisory Board voted unanimously to support the project.

The project supports the City of Fort Lauderdale Fast Forward Fort Lauderdale vision to have a connected community, as well as the City's Vision Zero Initiative to improve safety for all users.

## **Resource Impact**

There is no fiscal impact associated with this action. Design and construction will be funded by the City of Tamarac through the Complete Streets and Localized Initiatives Program (CSLIP) grant.
