## **RESOLUTION NO. 18-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, IN SUPPORT OF THE CITY OF TAMARAC'S COMPLETE STREETS AND OTHER LOCALIZED INITIATIVES PROGRAM APPLICATION TO ADD BIKE LANES, SIDEWALKS, AND CURBS AND GUTTERS, ALONG PROSPECT ROAD BETWEEN NW 31ST AVENUE AND COMMERCIAL BOULEVARD WITHIN THE CITY OF FORT LAUDERDALE'S RIGHT-OF-WAY.

WHEREAS, the Broward Metropolitan Planning Organization (MPO) provides funds to eligible local governments for transportation related projects, such as traffic calming and bike facilities, through their Complete Streets and Other Localized Initiatives Program (CSLIP); and

WHEREAS, the MPO will disburse competitive grant funding to local governments based on applications submitted; and

WHEREAS, the project is expected to aid in the realization of the "We Are Connected" goal of the <u>Fast Forward Fort Lauderdale Vision</u>, by improving transportation options including bike lanes and improved pedestrian accommodations; and

WHEREAS, the proposed project is in compliance with the City of Fort Lauderdale's Complete Streets Policy; and

WHEREAS, the proposed project is expected to implement the Connecting the Blocks Program, by increasing connectivity for multiple modes of transportation; and

WHEREAS, the proposed project is consistent with the City's Vision Zero Initiative of improving safety for all users with a goal of zero fatalities and serious injuries; and

WHEREAS, the City of Fort Lauderdale City Commission supports the City of Tamarac's application for the Prospect Road Complete Streets project between NW 31<sup>st</sup> Avenue and Commercial Boulevard to be submitted by Broward County to the MPO's CSLIP to receiving funding; and

WHEREAS, the City of Fort Lauderdale supports the Florida Department of Transportation's management of the design and construction of the Prospect Road Complete Streets project, if selected, on the City's behalf;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:
